Announcement of Results: Announcement will be posted on the website of Bank of China (Hong Kong) www.bochk.com in or around March 2017. The winners will be separately notified by mail.

- 1. No restriction on the number of entries submitted by an entrant.
- 2. **8R** (8"x10") size coloured photo in film or digital format will be accepted. Photo(s) must be submitted together with film or CD-Rom with digital files. Digital photos must be of 8 million pixels or above.
- 3. Entry photo should be mounted on a 10"x12" black cardboard with a duly completed entry form attached to the back of the board.
- 4. Colour short film(s) with duration less than 2 minutes, in MOV, MP4, M4V or WMV format is accepted. Short film must be in HD format and 1920x1080 pixels. Entrant(s) must submit a CD-Rom/DVD with the short film saved in it, together with a duly completed entry form. Name of the entrant must be stated clearly on the disc envelope.
- 5. Cropping, darkroom techniques and computer processing to fine-tune the colour, brightness and contrast are allowed. However, no photo composing will be accepted.
- 6. Entrant must ensure that the entry(ies) is (are) original work of the entrant, and warrant that the entry(ies) does (do) not infringe upon any third-party rights, including but not limited to intellectual property rights, and/or privacy rights under Personal Data (Privacy) Ordinance (Cap.486). Bank of China (Hong Kong) shall not be liable for any legal disputes arising from such infringements. Entries must be neither previously published nor having won any awards in any other competitions. Bank of China (Hong Kong) reserves the right to take action against entrants for any infringement of the rights described herein.
- 7. Each entrant will have the opportunity to win one prize only.
- 8. All submitted entries including film, CD-Rom or DVD will not be returned. All submitted computer files will be scanned against virus and any file certified as infected will be deleted immediately.
