**Evaluation Criteria:** Creativity, Thematic approach, Layout, Technique

**Judging and Awards:** All entries will be evaluated by a panel of judges comprising of professional photographers from Hong Kong (panel members to be duly announced).

**Prizes:**

Champion (1 award)	A commemorative trophy and HK\$30,000 cash prize
First runner-up (1 award)	A commemorative trophy and HK\$20,000 cash prize
Second runner-up (1 award)	A commemorative trophy and HK\$10,000 cash prize
Merit (30 awards)	A certificate of merit and HK\$1,000 cash prize for each

**Results Announcement:** Announcement of the winners will be posted on Bank of China (Hong Kong)'s website ([www.bochk.com](http://www.bochk.com)) and will be published in newspapers in August. Details to be duly disclosed. The winners will be notified individually by mail.

**Winning Exhibition:** All winning entries and selected works will be exhibited at the Lobby of the Bank of China Tower or other public display venues. Details to be duly disclosed.

- No restriction on the number of photos submitted by an entrant.
- 8R (8"x10") size coloured photo in film, slide or digital format will be accepted. Photos must be submitted together with film/slide/CD with digital files. Cropping, darkroom techniques and special computer processing are allowed. Digital photos must be 5 million pixels or above.
- Entries should be mounted on a 10"x12" black cardboard with a completed entry form attached to the back of the board.
- All entries must be original work of the entrant who should ensure there is no infringement of the rights of others (including copyright). Entrant submitting an entry that has prior awards from other competitions will be disqualified.
- Each entrant will have the opportunity to be awarded one prize only.
- All submitted entries including film/slide/CD will not be returned. All submitted computer files will be scanned against virus and any file certified as infected will be deleted immediately. Under those circumstances Bank of China (Hong Kong) reserves the right to disqualify the entrant from the competition.
- Bank of China (Hong Kong) reserves the right to use any entry photo for publicity, exhibition and publication purposes, including but not limited to graphic or electronic media. No prior notification or copyright fee will be given.
