## 'e-CNY – Grab e-CNY Tax Refund consumption red packets up to 50 e-CNY' Promotion (the "Promotion"):

- a. The promotion period runs from 20 June 2025 to 6 July 2025 (both dates inclusive) (the "Promotion Period").
- b. e-CNY (also known as digital Renminbi) is a digital currency issued by the People's Bank of China ("PBOC") and which is held in electronic e-CNY wallets ("Wallet(s)") provided by operators authorised by the PBOC outside of the Hong Kong Special Administrative Region of the People's Republic of China ("Hong Kong"). The Promotion is provided by Bank of China (Hong Kong) Limited (the "Bank", "BOCHK", "us", "our" or "we", and includes the Bank's successors and assigns), and is applicable only to Wallets provided by Bank of China Limited ("BOC") (such Wallets are hereinafter referred to as "BOC Wallets"). The e-CNY App is the only official platform that offers e-CNY related services to individual users ("e-CNY App").
- c. The Promotion is only applicable to customers who have:
  - successfully registered as a user of our BoC Pay+ <u>Mobile Application ("BoC Pay+") with a Hong Kong</u> <u>mobile phone number starting with the area code</u> <u>"+852" (the "Registered Mobile Number");</u> and

  - (iii) have accepted (and continue to enjoy) BoC Pay+ e-CNY zone service.

Eligible Customer who want to use the e-CNY consumption red packets in this promotion must use a Hong Kong mobile phone number with an area code starting with +852 to register/log in as an e-CNY user, and select e-CNY as the Payment method to complete the consumption. The purchase of virtual goods, such as purchasing coupons and gift cards, is not currently supported. Whether the actual Payment method supports e-CNY shall be subject to the layout display in designated malls.
- i. The Red Packets will be made available in the BOC Wallet of the Eligible Customer promptly and is valid until 6 July 2025 unless otherwise determined by the relevant provider from

such date ("Validity Period"), provided that such Red Packets must be used within the Validity Period. Any unused Red Packet remaining after the end of the Validity Period shall be deemed to be invalid and can no longer be used.

- j. For the terms and conditions applicable to the Red Packets, please refer to the related terms and conditions as set out in the e-CNY App and such terms and conditions as may be issued by the relevant provider from time to time.
- k. The availability of the Red Packets is subject to the records of BOCHK (which shall prevail in the event of any discrepancy), as well as other related terms and conditions as BOCHK and/or the relevant provider and merchants may specify from time to time (including those set out under General Terms and Conditions below).
- Without prejudice to any other rights, you acknowledge, agree and authorize BOCHK to collect and transmit your Registered Mobile Number to BOC, the issuer of e-CNY (the PBOC), and, where applicable, BOC Credit Card (International) Limited ("BOCCC") for the purposes of processing and disbursing the Red Packet into your BOC Wallet. Other terms and conditions as BOCHK may specify from time to time in relation to the disclosure, use and transmission of your personal information shall also continue to apply.

- m. Once the red packets grabbed has been completed, all information provided by you shall be final and irrevocable, and cannot be cancelled, altered or changed.
- n. If you wish to de-register from the Promotion and/or cancel the BOC Wallet, all the unused Red Packets will be void. Please call the BOCHK's Customer Service Hotline at 3988 2388 to apply for such de-registration and for further details.
- o. Any false trading, fraudulent, unauthorized and/or illegal transaction by you will result in your disqualification from the Promotion and the cancellation of any unused Red Packets provided to you, without BOCHK giving any prior notice or reason. s. <u>The e-CNY held in the Wallets (including BOC Wallets) are</u> <u>not deposits held in an ordinary bank account.</u> <u>Accordingly, the e-CNY amounts held in the Wallets</u> <u>(including BOC Wallets) are not protected deposits and are</u> <u>not protected by the Deposit Protection Scheme in Hong</u> <u>Kong.</u>
