- 7. Eligible local dining transaction includes local dining spending with machine printed sales slip, but with exclusion of spending on/at banquet services, private parties/functions, private room events, dining outlets in department stores, social/sports associations or clubhouses or such other non-dining merchants and non-acceptable dining spending as may be defined from time to time by UnionPay International /Visa Worldwide Pte. Limited and MasterCard Asia Pacific (Hong Kong) Limited according to their respective merchant category (the "Eligible Local Dining Transaction").
- 8.
