


Terms and Conditions of “Up to HK\$40 Instant Cash Discount at CRVanguard Supermarket and U select”:

1. “Up to HK\$40 Instant Cash Discount at CRVanguard Supermarket and U select”(the “Promotion”) commences from 1 September to 31 October 2018 (both dates inclusive) (the “Promotion Period”).
2. The Promotion is applicable to BOC Credit Card, BOC Dual Currency Credit Card and all BOC Co-branded Credit Card bearing the  logo issued in Hong Kong (the “Eligible Credit Card”), excluding BOC Credit Card issued in the mainland or Macau, BOC USD Credit Card, Great Wall International Card, Private Label Card, Purchasing Card, Prepaid Card, BOC Express Cash Card and Intown Card.
3. Mobile payment (refers to the contactless payment made with Eligible Credit Card that has been provisioned on the designated mobile phone or device) includes Apple Pay, Google Pay and Samsung Pay. Apple Pay only applies to the Eligible Credit Card (not eligible to Commercial Card); Google Pay and Samsung Pay applies only to the Eligible Credit Card (not eligible to Commercial Card and BOC Dual Currency Credit Card) (the “Mobile Payment”). To enjoy the relevant offer, cardholder needs to present the added Eligible Credit Card in the relevant mobile app to the cashier before payment and settling the payment successfully.
4. During the Promotion Period, cardholders who made any single net spending of HK\$300 or above (the “Eligible Transaction”) via Mobile Payment with Eligible BOC Visa Credit Card, or spending with BOC GOOD DAY Visa Platinum Card at CRVanguard Supermarket and U select (the “Merchants”), will receive an instant cash discount of HK\$40 (the “Offers”). Whereas cardholders who made any Eligible Transaction, with other Eligible BOC Credit Card (Physical card) or spending via Mobile Payment with other Eligible BOC Credit Card, will receive HK\$30 instant cash discount (the “Offers”).
5. The Offers are subject to a total of 13,000 quotas, with limited supply and available on a first-come-first-served basis while stocks last. The quota is calculated based on the computer record of BOC Credit Card (International) Limited (the “Company”) and the Merchants.
6. The Offers are only applicable at the Merchant outlets in Hong Kong; the Offers are not applicable to online transaction.
7. Each cardholder can enjoy the Offers once per day during the Promotion Period.
8. The Offers apply to single Eligible Transaction on one single sales slip. Split transactions are not eligible in the Promotion.
9. “Year Round 8% discount offer of BOC GOOD DAY Platinum Card (the “8% Year Round discount”) is applicable at the Merchants, but not applicable to Mobile Payment transactions. To enjoy the 8% Year Round discount, cardholder is required to purchase eligible items upon net spending of HK\$100 or above and payment must be fully settled by a BOC GOOD DAY Platinum Card during the 2nd, 12th and 22nd of every month.

Cardholders will be entitled to the Offers of the Promotion upon single net spending of HK\$300 or above with BOC GOOD DAY Platinum Card, and the Eligible Transaction will be calculated after the deduction of 8% Year Round discount.

10. The 8% Year Round discount cannot be used in conjunction with CRVanguard Rewards Card/ Fun Fun Card, CRVanguard Gift Voucher/ cash coupon and other offers. Other terms and conditions apply to the 8% Year Round discount offer at CRVanguard for BOC GOOD DAY Platinum Card, please visit www.bochk.com/creditcard for details.
11. The Offer cannot be used in conjunction with any other promotion offers, exchanged for cash, other products and are non-transferable.
12. The environmental levy on shopping bags imposed by the Hong Kong Government is excluded from the Eligible Transaction. Eligible Transaction refers to the final net amount payable when making the purchase with Eligible Credit Card by the cardholder. The amount of use of gift vouchers, CRVanguard's coupons and other discount privileges will not be taken into account when calculating the Eligible Transaction.

The Offers are not applicable to cigarette, cigar, baby milk powder (any model), baby diapers, spirits, abalone, mooncakes, designated Chinese New Year Gifting and designated healthcare products, redemption products, in-store designated counter products and other services: Octopus Card Reloads, Bill Payment, charity fee, Online Game Pack, Online Game Point Card, Prepaid Phone Cards/Reload Coupons/Phone Cards, Broadband Internet Prepaid Card, Gift card, any of the tickets/ stamps, fax/ copies services, mobile battery recharge services, courier delivery/collection/prepaid/preorder services, purchase of CRVanguard gift voucher, Easy Cash withdrawal service, the charge of plastic shopping bags, recycle bags, wholesales or credit sales products. The Merchants reserve the right to amend the list of ineligible products without prior notice.
14. The Offers will be given upon the completion of the Eligible Transaction immediately and cannot be accumulated or deferred for future use.
15. Any fraudulent, unauthorized, unposted, cancelled or refunded transaction will not be deemed as Eligible Transaction and will not be qualified for the Promotion. Only Eligible Transaction determined by the Company is eligible for the Promotion.
16. The Offers carry no money value and cannot be exchanged for cash, other products, services or discount.
