中銀信用卡(國際)有限公司(「卡公司」)及大豐銀行 有限公司(「銀行」),以本持卡人合約(「本合約」) 下列條款及條件發出信用卡(詳見下文釋義)

## 1. 釋義

1.1 在本合約中,除文義另有所指,否則以下詞語應 具以下涵義

「帳戶」指由卡公司以持卡人名義開立及維持, 並用作記入收費之澳門幣帳戶或人民幣帳戶 「附屬卡」指由卡公司在主卡持卡人及其提名之 附屬卡持卡人共同要求下,發給該附屬卡持卡人 之信用卡;

「附屬卡持卡人」指任何以其名義獲發附屬卡之

「自動櫃員機」指在聯網內及卡公司不時公布的 其他網絡使用的任何自動櫃員機

「信用卡」指由卡公司發出之任何雙幣信用卡, 包括受本合約規限的主卡及附屬卡,以及信用卡 之任何續發新卡或補發卡

「持卡人」指任何以其名義獲發信用卡之人,包 括主卡持卡人及附屬卡持卡人 (視乎文意所指者 而定)

「收費」指所有使用信用卡購買貨物及/ 或服務 及/或作現金透支之全部總值或金額,以及所有 有關之費用、收費、利息、訴訟費及開支

「人民幣」指人民幣,中華人民共和國之法定貨幣 「人民幣帳戶」指由卡公司以持卡人名義開立及 維持,並為根據本合約使用信用卡作人民幣提存 記錄之人民幣帳戶

「銀聯」指中國銀聯股份有限公司,一所於中華 人民共和國成立之股份有限責任公司,並於中華 人民共和國上海設有總部

「收費表」指列載不時有效及適用於信用卡之年 費、現金透支手續費、逾期收費、利息及其他費 用及收費之附表

「香港」指中華人民共和國香港特別行政區 「澳門」指中華人民共和國澳門特別行政區

「澳門幣」指澳門元,澳門之法定貨幣 「澳門幣帳戶」指由卡公司以持卡人名義開立及 維持,並為根據本合約使用信用卡作澳門幣提存

記錄之澳門幣帳戶 「主卡」指由卡公司發給主卡持卡人之信用卡, 並透過該信用卡發出一張或多張附屬卡

「主卡持卡人」指任何以其名義獲發主卡之人; 「中國內地」指中華人民共和國任何部份,但並

不包括香港、澳門及台灣地區 「聯網」指貼有銀聯不時採用的標記的自動櫃員 機聯網及該等由卡公司不時指定之自動櫃員機聯

「新交易」就一份結單而言,指持卡人透過使用 信用卡引致任何收費的交易,而該交易於以下時 間發生

- (a) 於該結單上所載最後一宗透過使用信用卡完 成的交易的時間(「有關時間」)之後的任 何時間;或
- (b) 於有關時間之前的任何時間,如果該交易所 招致的收費於該結單日期仍未記入帳戶亦未 於該結單上顯示

「私人密碼」就信用卡而言,指持卡人透過信用卡 獲取卡公司不時提供服務所需的個人識別密碼。

- 1.2 除非文意另有所指外,在本合約中,凡表示單數 之文字,其涵義包含複數,反之亦然;凡提述一 種性別,其涵義包含各種性別。
- 1.3 如文意許可或有所指,凡提述卡公司,將當作包 括提述其承繼人及承讓人。
- 信用卡之發出
- 2.1 卡公司可(酌情決定)根據本合約的條款及條件 向持卡人發出一張或多張信用卡。卡公司在發出 信用卡時,將開立及維持用以借記及/或貸記收 費的帳戶。
- 2.2 由主卡持卡人提出申請,並獲得卡公司(酌情決 定)批准後,卡公司可向該主卡持卡人提名的附 屬卡持卡人發出一張或多張附屬卡。
- 2.3 持卡人須於收到卡公司發出信用卡之後立即:
  - (a) 於信用卡上所預留之空白處簽署;及 (b) <u>按照卡公司的指示,簽署信用卡之確認收妥</u> 回條並交回卡公司或根據卡公司指示的其他 <u>方式使信用卡生效。</u>
- 2.4 持卡人於信用卡上簽署或使用信用卡或使信用卡 生效,將構成持卡人接受本合約的條款及條件並 同意受其約束之確證。
- 2.5 卡公司一般將於信用卡到期前至少30天續發新 卡。除非於該30天期內卡公司收到終止信用卡 之書面通知,否則持卡人將被當作於到期日收到 續發新卡。持卡人使續發新卡生效或使用續發新 卡,或於信用卡到期日後繼續使用信用卡,將被 當作持卡人已接受續發新卡。
- 2.6 卡公司有權拒絕為持卡人失去或被竊之信用卡補 發新卡。卡公司有權就所發出之補發卡按照收費

- 表收取手續費。
- 信用卡之使用 3. 3.1 信用卡只限於持卡人專用於真誠地購買貨物及/ 或服務及/或作現金透支。持卡人不得將信用 卡用作任何其他用途,尤其不得用作任何違法用 途,包括(但不限於)作為任何違法交易的付款 用途。就在任何其他國家或中國內地使用信用卡 進行的信用卡交易,持卡人亦須遵守不時在該國 家或中國內地實施的所有法律及規定。
- 3.2 持卡人不得將卡轉讓予任何人,亦不得容許任何 人使用信用卡或以抵押方式典押信用卡作任何用
- 3.3 信用卡是以澳門幣和人民幣為貨幣單位,並只供 持卡人在中國內地、澳門及卡公司不時指定的地 方於使用銀聯 POS 系統或與之連接的商戶或財 務機構用於真誠地購買貨物及/或服務及/或於 自動櫃員機或銀行櫃位作現金透支之用及卡公司 不時提供的其他信用卡設施或服務。
- 3.4 所有以澳門幣為貨幣單位的信用卡交易,將記入 澳門幣帳戶內。所有以非澳門幣或非人民幣為貨 幣單位的信用卡交易收費,均會參考銀聯於折算 當日釐定的匯率折算為澳門幣,加上卡公司按收 ] 費表收取的手續費 ( 若適用 ) <sup>,</sup> 記入澳門幣帳戶
- 3.5 除第3.6 條所述的情況下,所有以人民幣為貨幣 單位的信用卡交易收費,將記入人民幣帳戶內。
- 3.6 由於清算安排,某些以人民幣為貨幣單位的信用 卡交易,或因商戶或財務機構以澳門幣處理有關 信用卡的交易,包括但不限於經由銀通自動櫃員 機進行的提取現金的收費,其收費將可能記入澳 門幣帳戶內。
- 4. 信用限額
- 4.1 <u>卡公司可不時(酌情)決定由卡公司發給持卡人</u> <u>的任何信用卡的信用限額及/ 或現金透支限額及/</u> <u>或每日現金透支限額。</u>如獲發附屬卡,主卡持卡 人及附屬卡持卡人可各自獲得獨立信用限額及/ 或現金透支限額,或按卡公司(絕對酌情)不時 決定之比例共用任何信用限額及/ 或現金透支限
- 4.2 <u>持卡人須嚴格遵從卡公司不時釐定的信用限額、</u> <u>現金透支限額及每日現金透支限額,並在使用信</u> <u>用卡時不得超越該信用限額及/ 或現金透支限額</u> <u>及/ 或每日現金透支限額。持卡人不會因違反第</u> <u>4.2 條而得以減低或免除其對於因違反此條款所</u> 引致任何收費的付款責任,卡公司並有權按收費 <u>表列載的收費率收取手續費。</u>
- 4.3 於收到卡公司要求後,持卡人須即時向卡公司支 <u>付超越該信用限額的款項。</u>
- 4.4 <u>卡公司有權就每次向持卡人提供現金透支服務,</u> <u>根據收費表列載的收費率收取手續費。</u>
- 帳戶結單與付款方法
- 5.1 <u>卡公司將每月或定期向持卡人寄發帳戶結單</u> <u>(「結單」),列明(其中包括)截至結單上所述</u> <u>月結期最後一日的帳戶(包括澳門幣帳戶及人民</u> <u> 幣帳戶) 結欠(「結欠金額」) 及持卡人就有關結</u> 欠金額之最低還款額(「最低還款額」)及到期付 <u>款日 (「到期付款日」),除非自上期結單後並沒</u> 有新交易。
- 5.2 除非卡公司於結單日期起計 60 天內收到持卡人 <u>的書面通知指稱結單所載交易有誤,否則卡公司</u> <u>有權把該結單內所載之交易視作正確無誤。</u>
- 5.3 <u>持卡人須於接獲結單後即時支付已到期付款之結</u> <u>欠金額。</u>
- 5.4 若卡公司在到期付款日或之前收到結欠金額,持 卡人則毋須就該結欠金額支付利息。<u>若卡公司在</u> 到期付款日時仍未收到或僅收到少於結欠金額之 <u>付款,持卡人則須按收費表列載之息率(該息率</u> 於法庭裁決前後均為適用)支付(i)該等尚未償還 <u>款項按日計算之利息,由結單日期起計,直至清</u> <u>還全部欠款為止及 (ii) 每一宗新交易之金額按日</u> <u>計算之利息,由該宗新交易之交易日起計,直至</u> <u>清還該金額之全部為止。所有利息將按月或定期</u> 記入帳戶。
- 5.5 <u>若卡公司在到期付款日或之前仍未收到或收到少</u> 於最低還款額之付款,則除須根據第5.4條支付 <u>未償還欠款應付之利息外,持卡人亦須支付按收</u> 費表列載之逾期收費。逾期收費將於下一結單日 <u>(「下-結單日」)記入帳戶。</u>
- 5.6 持卡人支付任何款項的日期須被視為卡公司實際 收訖即可提用款項的當日。倘以銀行本票或任何 其他同類票據付款,則只會將扣除處理該銀行本 票或票據之一切收款、行政或手續費用後之淨額 記入帳戶內。
- 5.7 <u>所有根據本合約繳交給卡公司以清還澳門幣帳戶</u> <u>之款項,須以澳門幣支付,但卡公司有權酌情</u> 接受其他貨幣之付款。如卡公司接受非澳門幣付 <u>款,該付款可根據卡公司釐定的匯率折算為澳門</u> 幣後記入澳門幣帳戶,而卡公司有權按收費表收 <u>取兑換費(若適用),並記入澳門幣帳戶。在受第</u> 5.11 條規限的情況下,清還澳門幣帳戶後的超額 <u>款項,不可用作繳交人民幣帳戶內的未付結欠。</u>
- 5.8 所有根據本合約繳交給卡公司以清還人民幣帳戶 <u>之款項,須以人民幣支付,但卡公司有權酌情</u> <u>接受其他貨幣之付款。如卡公司接受非人民幣付</u>

款,該付款可根據卡公司釐定的匯率折算為人民 幣後記入人民幣帳戶,而卡公司有權按收費表收 <u>取兑換費(若適用),並記入人民幣帳戶。若現金</u> 付款的金額高於收款機構訂定之任何最高限額 <u>該收款機構有權就該付款收取行政或手續費。在</u> 受第5.11條規限的情況下,清還人民幣帳戶後的 超額款項,不可用作繳交澳門幣帳戶內的未付結 欠。

- 5.9 <u>從持卡人收到之付款,將按以下先後次序或卡公</u> 司不時絕對酌情決定之其他先後次序用於償還帳 <u> 戶結欠</u>:
  - (a) <u>現金透支的利</u>息;
  - (b) <u>零售消費的利息</u>;
  - <u>服務收費或費用;</u> (c)
  - <u>超越限額手續費及逾期費用;</u> (d)
  - 現金透支的本金結欠; (e)
  - (f) <u>零售消費的本金結欠;</u>
  - <u>年費;及</u> (q) <u>收款費用、法律費用及就卡公司執行本協議</u> (h) <u>之費用。</u>
- 5.10 <u>如獲發附屬卡,主卡持卡人所付的款項,將按照</u> <u>卡公司不時絕對酌情決定的先後次序及優先次</u> <u>序,用於支付主卡持卡人及附屬卡持卡人各自所</u> <u>欠的款項。</u>
- 5.11 <u>卡公司有權(絕對酌情決定)拒絕接受任何超越</u> <u>帳戶結欠金額的款項存入帳戶。若帳戶內有任何</u> <u>溢餘款項,卡公司有權在帳戶出現結欠金額時將</u> <u>該超額款項用以支付該結欠金額</u>
- 5.12 <u>倘若在清還所有未付收費及卡公司向持卡人之申</u> <u>索後,帳戶仍然有任何結餘(「結餘」),則卡公</u> <u>司可在任何時間主動或在合理時間內應持卡人要</u> <u>求或於主卡終止時向持卡人退還有關結餘。</u>
- 5.13 <u>澳門幣帳戶內的結餘,卡公司須以澳門幣退還。</u> 人民幣帳戶內的結餘,卡公司可按其獨有酌情權 決定以澳門幣(必先按卡公司釐定的匯率由人民 幣折算至澳門幣)或人民幣於澳門境內其指定的 <u>地點及方式退還。卡公司有權就每次退還結餘按</u> <u> 收費表收取手續費。</u>
- 5.14 <u>所有收費,即使是(不限於)以(i)電話、傳真、</u> <u>郵遞訂購或直接扣帳授權方式作出,或 (ii) 在互</u> <u> 聯網、商戶或財務機構售點終端機、信用卡繳款</u> <u>電話或准許使用信用卡而無須簽署銷售單據或由</u> <u>持卡人簽署的其他設施上使用信用卡作出,仍可</u> 記入帳戶。持卡人沒有簽署任何銷售單據或現金 <u>透支憑單,並不免除持卡人就此對卡公司應負之</u> 責任。
- 6. 費用、收費及息率
- <u>持卡人根據本合約應付之一切費用、收費及利</u> 6.1 <u>息,詳情已載於收費表內,並須按收費表支付。</u>
- 6.2 卡公司可按照第20條不時(酌情決定)修訂收費 <u>表。收費表之最新文本可於卡公司澳門辦事處、</u> <u>銀行索取及卡公司之網站(網址 www.bochk.co</u> m/creditcard/macau/) 瀏覽。
- 6.3 <u>如獲發附屬卡,則就一切用意及目的而言,卡公</u> <u>司均可 (絕對酌情決定)將使用任何附屬卡產生</u> <u>的任何或所有費用、收費及/或利息,當作由主</u> <u>卡持卡人產生處理。</u>
- 7. 持卡人義務與責任 7.1 <u>持卡人須採取合理措施,妥善保管信用卡及私人</u> <u>密碼,亦須將私人密碼保密。在不影響前文所載</u> <u>的一般原則下,持卡人必須採取以下各項措施,</u> <u>確保信用卡安全及將私人密碼保密,藉此防止發</u>
  - <u>生欺詐事件</u>
  - (a) <u>私人密碼應與信用卡分開存放;</u>
  - <u>銷毀私人密碼通知書正本</u> (b)
  - <u>切勿將私人密碼寫在信用卡上或通常與信用</u> (c) <u>卡一同存放或附近的任何物件上\_</u>
  - <u>不應直接寫下或記下個人密碼,而不加掩</u> (d)
  - 切勿使用常用個人資料作為私人密碼;
  - 按照卡公司不時發出的程序、指示及/ 或保 <u>安指引使用信用卡;及</u>
- <u>不得將其私人密碼告知他人或供他人使用。</u> 7.2 <u>如發生以下事件,在切實可行的合理情況下,持</u> <u> 卡人須致電卡公司熱線 (853) 8988-9933( 辦公時</u> <u>間內)或(852)2544-2222(非辦公時間內)通知</u> <u>卡公司,並於隨後 24 小時內或卡公司不時訂明</u> 的其他期間內以書面確認
  - (a) <u>信用卡及/或私人密碼遺失及/或被竊;</u>
  - (b) <u>未經授權使用信用卡及/ 或私人密碼;</u>
  - (c) 向未經授權人士披露私人密碼;
  - (d) <u>懷疑出現載有與信用卡相同卡號或聲稱根據</u> 帳戶發出的任何偽冒信用卡;及/或
  - <u>懷疑有未經授權使用信用卡及/或私人密碼</u> (e) <u> 及/ 或披露私人密碼。</u>
- 7.3 <u>在不損及第7.2 條所載的義務的情況下,持卡人</u> 須將有關事件通知警方,並在合理及切實可行的 <u>情況下,盡快將報警事宜的有關文件證據提交卡</u> <u>公司。</u>
- 7.4 卡公司有權按聲稱持卡人者發出的任何口頭或書 面指示行事。如卡公司因此採取任何行動,卡公 司毋須因有關行動而向持卡人承擔任何責任,亦 不會因此解除持卡人的任何責任。
- 7.5 儘管本文載有任何相反規定,持卡人於收到卡公

- 8. 未經授權交易
- 8.2 除卡公司控制範圍以外,卡公司須盡合理努力, 於收到持卡人通知未經授權的交易起計 90 天內 完成有關調查
- 8.3 <u>倘持卡人於到期付款日之前將任何未經授權的交</u> <u>易通知卡公司,並於調查期內暫緩繳付爭議金</u> 額,則卡公司保留權利,可按收費表所列之收費 率, 對爭議金額重新收取由交易日期(或卡公司 <u>不時絕對酌情決定的較後日期)至全數清償爭議</u> 金額為止期間的任何費用、收費及/或利息;如 其後證實持卡人提出的爭議並無根據,亦可收取 <u>一切有關費用、收費及/ 或利息。</u>
- 9. 持卡人對未經授權交易所負責任 9.1

- (b) <u>終端機或其他系統發生的故障,引致持卡人</u>

額;及

<u>及引致的責任承擔責任。</u>

11. 責任限免

- 8.1 持卡人須小心細閱結單,並須於結單日期起計 60 <u>天內,將結單內任何未經授權的交易通知卡公</u>

- <u>蒙受損失及損害,惟若有關故障是明顯的,</u> <u>或已顯示故障信息或通告則除外;及</u> (c) <u>交易是以偽造的信用卡進行的</u>。
- 9.2 在受適用法律及規定規限的情況下,只要持卡人 <u>以真誠態度及應有謹慎行事 ( 包括根據第 7.1 條</u>
  - <u>採取防範措施及按照第 7.2 條報失、報被竊及/</u> <u>或未經授權使用信用卡),則除非卡公司欺詐、</u> 嚴重疏忽或有故意失責行為
  - (a) <u>持卡人無須對其在將信用卡遺失、被竊及/</u> 或被未經授權使用等情況正式通知卡公司後 <u>發生的任何未經授權交易負責;</u>
  - (b) <u>持卡人對其在將信用卡遺失、被竊或被未</u> <u>經授權使用等情況(使用信用卡/私人密碼</u> <u>進行現金透支的情況除外)正式通知卡公司</u> 之前發生的任何未經授權交易所負的責任, 將不會超過卡公司不時通知持卡人之最高限
  - (c) <u>持卡人須對其在將信用卡/私人密碼遺失、</u> <u>被竊及/或被未經授權使用等情況正式通知</u> <u>卡公司之前使用信用卡/私人密碼進行的所</u> <u>有未經授權的現金透支負責。</u>
- 9.3 <u>儘管本文載有任何相反規定,若持卡人信用卡之</u> <u>遺失、被竊及/ 或被未經授權使用是由於持卡人</u> <u>有欺詐行為或嚴重疏忽,或未能遵照第7.1條或</u> <u>第7.2條之規定,或未能採取合理防範措施防止</u> <u>信用卡遺失、被竊及/或未經授權使用信用卡,</u> 或有關未經授權使用信用卡涉及在持卡人知情或 <u>不知情下使用持卡人的私人密碼,或如持卡人没</u> <u>有在合理可行的情況下盡快將信用卡/私人密碼</u> <u>的遺失、被竊及/ 或被未經授權使用等情況向卡</u> <u>公司報告(在此情況下,持卡人須對卡公司在收</u> <u>到持卡人就上述信用卡/私人密碼的遺失、被竊</u> <u> 及/ 或被未經授權使用等情況報告之前因而產生</u> <u>的一切損失及損害負責)。持卡人同意就因而合</u>
- <u>理地引致的一切損失、損害、責任及一切合理費</u> <u>用及開支而向卡公司作出及保持作出全數彌償。</u> 10. 主卡及附屬卡持卡人之責任
- 10.1 <u>主卡持卡人須 (與附屬卡持卡人共同及各別) 對</u> <u>附屬卡及/ 或透過使用附屬卡進行的任何及所有</u> <u>交易及/ 或引致的責任而向卡公司承擔責任。</u> 10.2 <u>附屬卡持卡人只須對其使用其附屬卡進行的交易</u>
- 11.1 受限於第9.1 條的規定及除任何可歸咎於卡公司 之欺詐行為、嚴重疏忽或故意忽略外,對於持卡 人直接蒙受或承擔的任何損失及責任,無論是否 因任何使用、不當使用信用卡、信用卡或卡公司 提供的其他裝置失靈失效,或任何卡公司就使用
- 信用卡所提供的服務,或持卡人使用信用卡而獲 得的任何貨品及服務,卡公司將一概不負責。 11.2 <u>如任何商號(包括任何財務機構)拒絕接納信用</u>
- 卡或拒絕以信用卡支付任何向持卡人提供的貨物 <u> 及服務,卡公司概不負責。</u> 11.3 卡公司亦保留權利,可絕對酌情決定拒絕將任何 商號或財務機構要求的任何收費記入帳戶。任何 持卡人針對任何商號或財務機構作出的索償或爭
- 議,應由持卡人與該商號或財務機構直接解決。 在任何情況下,有關索償或爭議並不解除本文所 載持卡人須向卡公司承擔的責任。 11.4 於卡公司收到任何商號或財務機構作出的退款及
  - <u>按卡公司所接受的格式開出的有關退款單據之</u> <u>前,卡公司概無責任將退款記入帳戶。</u>
- 11.5 所有於卡公司提供任何信用卡服務時而所引致之 延誤、失效或就卡公司履行本協議項下的義務時 而使用之電腦或其他裝置的失效,如為卡公司之

合理控制範圍以外之情況下,卡公司將一概不負

- 11.6 儘管本文載有任何相反規定,對於持卡人或任何 人士直接、間接或任何情況之下引起而蒙受或承 擔任何間接、相應或附帶損失、利潤或商機損失, 或其他種類的損失或損害,卡公司將一概不負 書。
- 11.7 就提供信用卡服務時,卡公司或會透過電話、傳 真、互聯網或其他卡公司不時指定的方式與持卡 人聯絡或索取指示。就此,持卡人現同意卡公司 記錄任何由該方式而索取之訊息及/或指示,並 將其保存至卡公司認為合適的期段。卡公司將以 真誠及謹慎行事的態度執行該訊息及/ 或指示而 毋須再向持卡人作進一步確認。除明顯錯誤外, 任何該訊息及/或指示將視為確實及對持卡人具 約束力。
- 11.8 如持卡人因故對卡公司提出任何法律程序,持卡 人同意卡公司所負的責任不會超過錯誤記入帳戶 的款額(以及該等款額的利息)。
- 12. 信用卡之終止與停用
- 12.1 持卡人隨時可向卡公司發出不少於 14 天事前書 面通知終止信用卡;惟儘管信用卡已被終止,持 卡人仍須負責一切透過使用信用卡所進行之交 易,直至全數付清帳戶內一切欠款(不論有否過 帳至帳戶亦然)為止。
- 12.2 如獲發附屬卡, 附屬卡持卡人隨時可向卡公司發 出不少於 14 天事前書面通知終止其附屬卡,而 主卡持卡人隨時可向卡公司發出以不少於 14 天 事前書面通知終止主卡及/ 或任何或所有附屬 卡。於主卡終止後,據其發出的所有附屬卡將即 時終止。儘管有關主卡及附屬卡已告終止,主卡 持卡人仍需負責一切透過使用主卡及所有附屬卡 所進行之交易,而每名附屬卡持卡人只需負責一 切透過使用其附屬卡進行之交易。

- 18.8 持卡人確認及同意由卡公司向持卡人提供的有關 交易/服務的若干服務、操作及處理程序,可 不時由卡公司外判至卡公司的區域或全球處理中 心、控股公司、分行、附屬公司、代表辦事處 附屬成員及代理人及由卡公司或上述任何一方所 挑選的任何第三方,不論其所在地,而此等服務 供應商可不時為著及就其執行之服務及程序獲取 有關持卡人及/ 或帳戶及/ 或卡公司向持卡人提 供的交易和服務的資料。
- 19. 通知

- 19.2 在不影響其他通訊方式的情況下,持卡人將在下 列情況下被視為已收悉任何月結單、通知、繳費 通知書或其他通訊
  - (a) 已在卡公司澳門辦事處張貼3個營業日;
  - (b) 在一份澳門報章刊登的3個營業日後;
  - 在卡公司網站刊登
  - 留交於持卡人在卡公司記錄中的任何地址。 或郵寄予該地址 48 小時後 ( 或如屬海外地 址則為7日後)
  - (e) 以電子郵件、訊息或圖文傳真發送往持卡人 在卡公司記錄中的電郵地址、設備或圖文傳 真號碼;或
  - 當透過電話或以其他口頭通訊轉達時(包括 留下話音訊息)。

即使郵件被退還 (如屬郵寄),或持卡人已身故或 喪失能力。「營業日」指銀行在澳門開門營業的 日子,不包括週日及公眾假期。

- 20. 修訂

TAI FUNG CUP DUAL CURRENCY CREDIT CARD USER AGREEMENT

The Card(s) (as defined below) is/are issued by BOC Credit Card (International) Ltd. (the "Company") and the Tai Fung Bank Limited (the "Bank") pursuant to the terms and conditions of the User Agreement (the "Agreement") below

### Interpretation

- 1.1 Unless the context otherwise requires, the following expressions shall have the following meanings in this
  - "Account" means either the MOP Account or CNY Account opened by and maintained with the Company under the name of the Cardholder to which the Charges shall be debited.
  - "Additional Card" means a Card issued by the Company to an Additional Cardholder nominated by the Main Cardholder and at the joint request of the Main Cardholde and such Additional Cardholder:
  - "Additional Cardholder" means any person to whom and in whose name an Additional Card is issued:
  - "ATM" means any automatic teller machine in operation in the Network and such other networks as from time to time announced by the Company;
  - "Card" means any dual currency card issued by the Company and includes Main Card and Additional Card subject to this Agreement and any renewal or replacement
  - "Cardholder" means any person to whom and in whose name a Card is issued and includes Main Cardholder and Additional Cardholder as the context requires;
  - "Charges" means the aggregate value or amount of all purchase of goods and/or services and/or cash advances effected by the use of the Card and all relevant fees. charges, interest, costs and expenses in connection therewith:
  - "CNY" means Renminbi yuan, the lawful currency of the People's Republic of China;
  - "CNY Account" means any CNY account opened by and maintained with the Company under the name of the Cardholder for the purposes of recording debits and credits in CNY in respect of usage of the Card under this Agreement
  - "CUP" means China UnionPay Company Limited, a joint stock limited liability company incorporated in the People's Republic of China with head quarters in Shanghai, the People's Republic of China;
  - "Fees Schedule" means the schedule setting out the annual fees, cash advance handling fee, late charge, interest and other fees and charges from time to time in force and applicable to the Card;
  - "Hong Kong" means the Hong Kong Special Administrative Region of the People's Republic of China: "Macau" means the Macau Special Administrative Region
  - of the People's Republic of China; "MOP" means Macau dollar, the lawful currency of Macau
  - "MOP Account" means any MOP account opened by and maintained with the Company under the name o the Cardholder for the purposes of recording debits and credits in MOP in respect of usage of the Card under this
  - "Main Card" means a Card issued by the Company to a Main Cardholder to which one or more Additional Cards are issued thereto;
  - "Main Cardholder" means any person to whom and in whose name a Main Card is issued:
  - "Mainland China" means any part of the People's Republic of China but excluding Hong Kong, Macau and Taiwan. "Network" means the network of ATM machines bearing
  - the logo from time to time adopted by CUP and such other network of ATM from time to time designated by the Company:
  - "New Transaction" means in relation to a Statement, a transaction by which the Cardholder has incurred any Charges through the use of the Card, occurring at any time after the time ("Relevant Time") at which
  - the last transaction as shown in that Statement was effected by the use of the Card: or
  - at any time before the Relevant Time, the Charges in respect of which have not as of the date of that Statement been debited to the Account and showr in that Statement.
- "PIN" means in relation to a Card, the personal identification number of the Cardholder required to gain access to services provided by the Company from time to time through the Card.
- 1.2 In this Agreement, words denoting the singular shall include the plural and vice versa and reference to one gender shall include all genders, unless the context otherwise requires
- 1.3 Any reference to the Company shall where the context permits or requires be deemed to include a reference to its successors and assigns.
- Issue of Cards
- 2.1 The Company may (in its discretion) issue one or more of the Cards to the Cardholder subject to the terms and conditions of this Agreement. When a Card is issued, the Company will set up and maintain the Account to which the Charges will be debited and/or credited.
- 2.2 Upon the application of the Main Cardholder and subject to the approval of the Company (in its discretion), the Company may issue one or more Additional Cards to the Additional Cardholders nominated by such Main Cardholde
- 2.3 Immediately upon receipt of the Card from the Company, the Cardholder shall:
- sign the Card on the space provided; and (b)
- sign and return to the Company any acknowledgment of receipt of such card or otherwise activate such Card in accordance with the instructions of the Company.
- 2.4 The signature of the Cardholder on the Card, or the use or activation of the Card by the Cardholder shall constitute conclusive evidence of the Cardholder's acceptance of and agreement to be bound by the terms and conditions of this Agreement.
- 2.5 A renewal Card shall normally be issued at least 30 days' prior to the expiry date of a Card. Unless written notice of termination of the Card is received by the Company within such 30 days' period, the renewal Card shall be deemed to have been received by the Cardholder by the expiry date. By activating or using the renewal Card or continuing to use the Card after its expiry date, the Cardholder shall be deemed to have accepted the renewal Card.
- 2.6 The Company shall have the right to refuse issuing a replacement Card to the Cardholder if his/her Card is lost or stolen. Where a replacement Card is issued, the Company shall be entitled to charge a handling fee for such replacement Card in accordance with the Fees

# Schedule

- Use of the Card Use of the Card is restricted exclusively to the Cardholder for bona fide purchase of goods and/or services and/ or cash advances only and the Cardholder shall not use the Card for any other purposes, in particular any illega purposes including without limitation payment for any llegal transaction. The Cardholder shall also observe all the laws and regulations from time to time in operation in any other country or Mainland China in relation to any Card Transaction conducted with the Card in such other country or Mainland China.
- The Cardholder shall not transfer the Card to any person or allow any person to use the Card or pledge the Card as security for whatever purposes.
- The Card is denominated in both MOP and CNY and is 3.3 valid for use by the Cardholder in Mainland China, Macau and such other places from time to time designated by the Company for bona fide purchase of goods and/or services and/or cash advance in merchant establishments or financial institutions which are using and connected to CUP's POS system and/or cash advances effected at the ATM or bank counter and such other credit card facilities or services as the Company may from time to time provide.
- 3.4 Currencies settled in respect of all Charges incurred in a card transactions effected by the use of the Card in MOP will be posted to the MOP Account. Currencies settled in respect of all Charges incurred in all card transactions effected by the use of the Card in currencies other than MOP or CNY shall be posted into the MOP Account after conversion into MOP at the prevailing rate of exchange determined by reference to the rate of exchange adopted by CUP on the date of conversion plus a handling fee (if applicable) charged by the Company as set out in the Fees Schedule.
- 3.5 Subject always to Clause 3.6, Charges incurred in all card transactions effected by the use of the Card in CNY will be posted to the CNY Account.
- 3.6 Charges incurred in certain card transactions effected by the use of the Card in CNY may be posted to the MOP Account due to the settlement arrangement if the card transactions are processed by the merchant establishments or financial institutions in MOP, including but not limited to Charges incurred through cash advances in CNY effected at the JETCO ATM. Credit Limit
- The Company may from time to time (in its discretion) <u>determine the credit limit and/or cash advance limit and/or</u> the daily cash advance limit in respect of any Card issued by the Company to the Cardholder. Where Additiona Cards are issued, the Main Cardholder and the Additional Cardholders may be subject to separate and independent credit limits and/or cash advance limit or may share any credit limits and/or cash advance limit in such proportion as the Company may (in its absolute discretion) from time o time determine
- 4.2 The Cardholder shall strictly observe the credit limit and cash advance limit and the daily cash advance lim imposed by the Company from time to time and shall not use the Card in excess of such credit limit and/or cash advance limit and/or the daily cash advance limit. Breach of this Clause 4.2 shall not in any way reduce or discharge the liability of the Cardholder for payment of any Charge arising as a result of such breach and the Company sha be entitled to charge a handling fee at the rate as set out <u>the Fees Schedule</u>
- 4.3 The Cardholder shall forthwith pay to the Company any amount in excess of such credit limit upon receipt of demand from the Company.
- The Company shall be entitled to charge a handling fee 4.4 at the rates as set out in the Fees Schedule on each cash advance made available to the Cardholder.
- Account Statement and Payment
- The Company shall send a statement of account to the Cardholder on a monthly or other periodic basis ("Statement") showing, inter alia, the balance in the Account (both the MOP Account and CNY Account) <u>as at the end of the statement period specified therein</u> ("Current Balance"), the minimum payment due from the Cardholder in respect of any Current Balance which is outstanding and due from the Cardholder ("Minimum Payment") and specifying a payment due date ("Due Date"), except where there is no New Transaction since <u>he last statement.</u>
- Unless the Company receives within 60 days from the 5.2 date of the Statement a notification in writing from the Cardholder to the contrary, the Company shall be entitled to treat all transactions shown on the Statement as <u>correct.</u>
- 5.3 Any Current Balance which is outstanding and due from the Cardholder shall be payable immediately upon receipt of the Statement.
- 5.4 If payment of the whole of such outstanding Current Balance is received by the Company on or before the Due Date, no interest shall be payable in respect of such Current Balance. If no payment or payment of less than the Current Balance is received by the Company on or pefore the Due Date, interest at a rate as set out in the Fees Schedule (which shall apply before as well as after judgment) shall be charged on (i) the unpaid balance from <u>the date of the Statement on a daily basis until payment</u> n full and (ii) the amount of each New Transaction from the date of that New Transaction on a daily basis until <u>payment in full. All interest charged shall be debited to the</u> Account on a monthly or other periodic basis.
- If no payment or payment of less than the Minimum Payment is received by the Company on or before the relevant Due Date, then in addition to the interest payable <u>on the unpaid balance pursuant to Clause 5.4, a late</u> charge as set out in the Fees Schedule shall be charged, which shall be debited to the Account on the date of the
- <u>Statement next following ("Next Statement Date").</u> 5.6 All payment made by the Cardholder shall be deemed to be made on the date on which immediately available fund is actually received by the Company. Where payment is made by means of a bank draft or any other similar instrument, only such amount net of all collection administrative or handling fees for processing such bank draft or instrument will be credited into the Account.
- 57 All payment made to the Company pursuant to this Agreement to settle the MOP Account shall be made in MOP subject to the Company's discretion to accept payment in other currencies. Should the Company accept payment rendered in currencies other than MOP such payment may be credited into the MOP Account after conversion into MOP at a rate determined by the <u>Company which may be subject to the payment of a</u> conversion fee (if applicable) as set out in the Fees Schedule, which conversion fee shall be debited to the MOP Account . Any excess payment in settlement of MOP

Account shall not be used to settle outstanding balance in

- CNY Account subject to Clause 5.11 All payment made to the Company pursuant to this Agreement to settle the CNY Account shall be made in CNY subject to the Company's discretion to accept payment in other currencies. - Personal Data and Account Information 18.1 The Cardholder hereby acknowledges that the Cardholder has received, read and understood the contents of the Data Policy Notice or such other document(s) issued under whatever name from time to time by the Company and certain of its related entities relating to their general policies on use, disclosure and transfer of personal data (as the same may be amended from time to time) ("DPN") and agrees that the contents of the DPN shall be binding on the Cardholder. Copies of the current version of the DPN are available at the Macau Office of the Company. the bank or on the website of the Company at www.bochk. m/creditcard/macau/
- 18.2 The Cardholder hereby authorizes the Company to use any information it may have concerning the Cardholder and/or the Account in accordance with the DPN
- 18.3 The Cardholder hereby also authorizes the Company to contact any information source for information the Company may require to operate the Account. The Company is further authorized by the Cardholder to compare such information with the information provided by the Cardholder for checking or to produce more data The Cardholder hereby also consents that the Company may, if necessary, use the results of such comparisons for the taking of appropriate action against the Cardholder regardless of whether such action may be adverse to his/ ner interest

- 18.6 The Company will treat information relating to the Cardholder as confidential, but unless consent is prohibited by law, the Cardholder consents to the transfer and disclosure by the Company of any information relating to the Cardholder to and between the holding companies, branches, subsidiaries, representative offices affiliates and agents of the Company and any third parties (including any networks, exchanges and clearing houses) selected by the Company or any of them (each a "transferee"), wherever situated, for confidential use (including for data processing, statistical, credit and risk analysis purposes). The Company and any of the transferees may transfer and disclose any such information to any person as required by any law, court, regulator or legal process in Macau, Hong Kong or any relevant overseas jurisdictions. This sub-clause 6 shall apply to the Cardholder subject to the DPN.
- 18.7 The Cardholder consents to the Cardholder information being transferred to another jurisdiction outside Macau and being used, processed and stored in or outside Macau by third parties on behalf of the Company. The Company vill contract with the third parties to take reasonable care to keep the Cardholder information confidential and to observe, in conformity with local laws and regulations Local, Hong Kong and overseas regulatory and judicial authorities may in certain circumstances have access to the Cardholder information.
- 18.8 The Cardholder acknowledges and agrees that some services, operational and processing procedures relating to the transactions/services provided by the Company to the Cardholder may from time to time be outsourced by the Company to regional or global processing centers holding companies, branches, subsidiaries, representative offices, affiliates and agents of the Company and third parties selected by the Company or any of them, wherever situated, and these service providers may from time to time be given access to information relating to the Cardholder and/or the Account and/or the transactions and services provided by the Company to the Cardholder for the purpose of or in relation to the services and procedures they perform
- Notice 19.1 Any notice given by the Cardholder hereunder shall be given in writing and delivered to the Company at its address at Avenida Praia Grande No.517, Edificio Commercial Nam Tung 11B, Macau.
- 19.2 Without affecting other methods of communication, any statement, notice, demand or other communications are deemed to be received by the Cardholder:

- 22.3 This Agreement shall be binding on each successor, personal representative and person lawfully acting on behalf of the Cardholder.
- 22.4 No failure to act, omission or delay by the Company to exercise or enforce any right under any terms and conditions of this Agreement shall operate as a waiver of such right, nor shall any single, partial or defective exercise of any right prevent any other or further exercise of it or the exercise of any other right.
- 22.5 The Cardholder may not assign any of his/her rights and/ or obligations under this Agreement. The Company may assign or transfer any of its rights and obligations under this Agreement to any third party.
