Terms and Conditions:

1. To: The Hong Kong and China Gas Company Limited ("HKCGC") and BOC Credit Card (International) Ltd. ("BOCCC")

In consideration of HKCGC agreeing to the above arrangement, I acknowledge and agree that HKCGC can disclose the following information to BOCCC.  - BOCCC will debit any amount from my credit card account in accordance with the instructions from HKCGC and BOCCC shall not be required to verify any amount so charged;
 - in the event of insufficient credit card limit in my credit card account, BOCCC has the discretion whether or not to effect any autopay arrangement;
 - BOCCC shall not be responsible for any matter or dispute relating to the services provided by HKCGC or any claim or loss as a result of the autopay arrangement;
 - all matters or disputes relating to the autopay arrangement are subject to the final decision of BOCCC; and
 - in the event of discrepancy between the English and Chinese versions of the terms herein, the English version shall prevail.
