

**Terms & Conditions of “BOC CEA Dual Currency Credit Card” Welcome Offer:**

1. The promotion period runs until 30 June 2025. Only applicants whose BOC CEA Dual Currency Credit Card (“Eligible Credit Card”) applications are approved within the promotion period will be eligible for the welcome offer.
2. Eligible Transaction includes retail transactions and excludes cash advance, Cash Before Card, unposted amount of merchant installment program, annual fee, financial fee, handling fee, balance transfer, gift redemption fee, net of amount redeemed under ‘Instant Reward’, online bill payment, online bill payment instalments, payment by credit card via internet banking or online payment system to designated merchants, tax payments, mail order, telephone or fax order, casino transactions, Octopus Add Value, for purchase and/or reloads of store-value cards/gift cards or e-wallets, person to person (P2P) fund transfer via mobile device/app/electronic platform, gift delivery charges, investment transactions, any other transactions without sales slip and any other category as may be defined by the Company at its sole discretion from time to time. Main cardholder and additional/supplementary cardholder spending will be combined for calculation.
3. Eligible Credit Card applicants (“Cardholder”), who have selected the welcome offer of “3,000 Eastern Miles points”, are required to accumulate spending of Eligible Transaction HK\$2,000 or above in HKD account of the Eligible Credit Card within the first two months of card issuance in order to be eligible for the welcome offer.
4. Cardholder who have selected the welcome offer of “8,000 Eastern Miles points”, are required to accumulate spending of Eligible Transaction HK\$8,000 or above in HKD account of the Eligible Credit Card within the first two months of card issuance in order to be eligible for the welcome offer.

If the credit cards are not applied at the same time, the gift for the credit card first approved will be offered.

11. The Company accepts no liability for the quality of or any other matters relating to the welcome offer. The vendors are solely responsible for all the obligations and liabilities relating to the welcome offer.
