- 倘沒有設置拒納「超越信用限額」功能·卡公司可酌情決定信用卡在超越信用限額情況下仍可繼續使用;如因此引致月結單結欠超越信用總額·信用卡賬戶或將被收取超越信用限額手續費。

Terms & Conditions for opt-out of “Over-the-limit Facility” function

- Once the instruction to opt-out of “Over-the-limit Facility” function has been processed successfully, the Company will reject any overlimit transaction conducted on the relevant main and additional credit card(s) (if any); unless they are processed offline (such as, but not limited to, Octopus Automatic Add Value Service, contactless transaction, in flight or cruise transactions or recurring payment and so on), then no Overlimit Handling Fee of HK\$180 (per statement cycle) will apply.
- If a cardholder does not opt out of “Over-the-limit Facility” function as aforesaid, the Company may exercise its discretion to accept and process any overlimit transaction conducted with the said card. Thereupon an Overlimit Handling Fee will be debited to the account whenever its balance exceeds the “Combined Limit” amount specified on the monthly statement.
- If there is any conflict or inconsistency between the Chinese and English version, the latter shall prevail.
