

TERMS AND CONDITIONS OF PROMOTIONAL OFFERS

YEAR-ROUND DISCOUNT OFFER FOR BOC GOOD DAY PLATINUM CARD

U select (THE SUBSIDIARY OF CRVANGUARD) YEAR-ROUND DISCOUNT OFFER:

1. This offer is not applicable to Octopus Reload, Environmental Levy on Plastic Shopping Bags, recycle bags, purchase of Gift Voucher, cigarettes, milk powder (any model, include baby milk powder and adult milk powder), baby diapers, spirits, abalone, in-store designated counter products, value added cards for mobile phones, newspapers/magazines, iTunes/ Google Gift Card, redemption products, wholesale or credit sales products, mooncakes, designated Chinese New Year Gifting, designated healthcare products; the list of ineligible products are subject to change from time to time without prior notice. 3. To be eligible for the offers, customer must settle full payment by a BOC GOOD DAY Platinum Card. The 8x Gift Points include the basic 1x Gift Point (HK\$1= 1 Gift Point) and the extra 7x Gift Points awarded under this program.
4. The extra 7x Gift Points will be credited to the Eligible Card account of the main cardholder in the billing cycle that follows the posting of the originating transactions.
5. All fraudulent transaction, unauthorized transaction, unsuccessful transaction, cancelled or refunded transactions will be excluded from this Promotion.
6. Only cardholders whose credit card accounts are valid and in good standing throughout the Promotion Period and at the time when the reward Gift Points are being awarded will be eligible for the reward. To confirm the reward Gift Points earned by each cardholder under this program the Company will authenticate the eligibility of each transaction by matching the cardholder records kept by the Company. If the information provided by cardholder differs from that of the Company records, the latter shall be final and conclusive.

Should the cardholder commit any abuse or fraudulent act, the Company shall cancel the eligibility of the respective cardholder for the offer and reverse out from the card account reward Gift Points so awarded or debit the account with a sum equivalent to the monetary value of the Gift Points awarded (in the ratio of every 25,000 Gift Points being equivalent to HK\$100) without prior notice. In the event of insufficient Gift Points for the purpose as aforesaid, the Company reserves its right to cancel the respective credit card account and/or take such legal actions as may be necessary.

5. All offers are applicable to designated merchant outlets in Hong Kong only.
6. No person other than the cardholder and the Company will have any right under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefits of any of the provisions of these terms and conditions.
