

BoC Pay+ Lucky Red Packet Terms and Conditions:

1. BoC Pay+ mobile application ("BoC Pay+") Lucky Red Packet ("the Promotion") period is on 23 February 2026 (the "Promotion Period").
2. The Promotion is applicable to customers who are holding Pay+ Wallet or Pay+ Wallet Lite during the Promotion Period ("Eligible Customer").
3. During the Promotion Period, customers can collect the e-coupon (the "e-coupon") through the "Main page" > "BoC Pay+ Lucky Red Packet Landing Page". The e-coupon will be stored in the "Collected Coupons" section under the "Coupons" page of the BoC Pay+ App.

4. During the Promotion Period, each customer is entitled to collect up to one of each type of e-coupon. Each e-coupon can only be used once. e-coupons are available on a first-come, first-served basis while quota lasts.

The e-coupon is applicable to the physical outlets of PARKnSHOP, FUSION, TASTE, TASTE X FRESH (applicable to TASTE checkout counter only), INTERNATIONAL, food le parc, GOURMET, GREAT FOOD HALL, EXPRESS, PARKnSHOP Frozen Food, Watsons, Pacific Coffee, SASA, JHC (collectively the "Designated Merchants").

By applying the e-coupon at Designated Merchants, Eligible Customer can get a HK\$8 discount upon single net spending of HK\$80 or above with e-coupon 3 and they can get a HK\$5 discount upon single net spending of HK\$50 or above with e-coupon 4 (the "Offer"). The validity of the e-coupon is until 8 March 2026. (the "Validity Period"). The Eligible Customer must use the e-coupon within the Validity Period. Only one e-coupon can be applied in each transaction. Customers must state the intention to settle payment via BoC Pay+ and present the e-coupon payment code in BoC Pay+ to cashier before payment successfully paid through the UnionPay network to enjoy the Offer.
