

Terms and Conditions of “BoC Pay+ mainland China merchant spending rebate”

1. This promotion (the "Promotion") runs:
 - i. Section 1: from 1 August 2025 to 31 August 2025;
 - ii. Section 2: from 1 September 2025 to 30 September 2025;
 - iii. Section 3: from 1 October 2025 to 31 October 2025;both dates inclusive on all of the above sections (the "Promotion Period").
2. The Promotion is applicable to QR Code payments made with the BoC Pay+ mobile app via UnionPay network. Transactions must be made through the UnionPay network during promotion period to enjoy offers.
3. During each section of the Promotion Period, Eligible Customers who purchase via BoC Pay+ at physical stores in mainland China can enjoy HK\$100 cash rebate upon accumulated spending of RMB2,000 or above ; Each Eligible Customer can enjoy the Offer 1 time per section during the Promotion Period. Each customer (based on Identification Document Number) is eligible to receive a maximum of HK\$300 Cash Rebate throughout the Promotion Period.
4. Eligible Transactions include purchases in physical stores through UnionPay Network, but do not include online transactions, bill payments, FPS transactions and transit code.
5. The Cash Rebate will be credited to the Pay+ wallet in the below schedule:
 - i. Section 1: before 31 October 2025;
 - ii. Section 2: before 30 November 2025;
 - iii. Section 3: before 31 December 2025.Only Eligible Transactions will be counted for the calculation of Cash Rebate.
6. During the Promotion Period and at the time when the Cash Rebate is credited, customer' s Pay+ wallet must be valid and in good standing in order to be eligible for the Promotion and receiving the Cash Rebate.

Bank of China (Hong Kong) Limited and/or BOC Credit Card (International) Ltd will determine the eligibility of each transaction by matching the cardholder transaction records held by Bank of China (Hong Kong) Limited and/or BOC Credit Card (International) Ltd. If the information from the cardholder differs from those of Bank of China (Hong Kong) Limited and/or BOC Credit Card (International) Ltd records, the latter shall be final and conclusive.
