

Terms and Conditions of “BoC Pay+ 2025 April – May F&B 5%off Instant Discount Offer”

1. “BoC Pay+ 2025 April - May F&B 5%off Instant Discount offer” (the "Promotion") runs from 1 April 2025 to 31 May 2025, both dates inclusive (the "Promotion Period").
2. The Promotion is applicable to QR Code payments made with the BoC Pay+ mobile app via UnionPay network. Transactions must be made through the UnionPay network during promotion period to enjoy offers.
3. During the Promotion Period, customers can enjoy an instant discount of 5%off upon payment (the “Offer”) via BoC Pay+ at designated merchants (the “Participating Merchants”)
4. The Offer is capped at maximum of HK\$10 on each applicable transaction.
