

**Terms and Conditions of “BoC Pay+ X Maxim's Chinese Cuisine Spending up to 5% Rebate” (“Offer 1”)**

1. Offer 1 runs from 13 July 2026 to 31 August 2026, both dates inclusive (the "Promotion Period").
2. Offer 1 is applicable to payments made with the BoC Pay+ mobile app via UnionPay network. Transactions must be made through the UnionPay network during promotion period to enjoy Offer 1. Offer 1 is not applicable to any spending made with any other mobile payment/e-wallet or any physical credit card.
3. During the Promotion Period, customers who make eligible transactions via BoC Pay+ mobile application at the designated restaurants under Maxim's Chinese Cuisine in Hong Kong (including all Maxim's Palace outlets, Serenade, all Jade Garden outlets, all Jasmine outlets, The Square, Shanghai Garden, all Chiuchow Garden Restaurant outlets, all Chiuchow Garden outlets, all Peking Garden Restaurant outlets, Duck Victoria, all M&C Duck outlets and wellwellwell) (collectively, the “Designated Restaurants”) can enjoy 5% cash rebate.
