i) Unless otherwise specified, eligible overseas retail transaction means retail transactions made

and settled in foreign currency but exclude foreign currency transactions settled in Hong Kong Dollars (based on the currency posted in the credit card statement).

ii) Unless otherwise specified, eligible online transaction means online transactions.
