

「Chill Date HYROX Experience Class Offer」 Promotion Terms and Conditions:

1. The promotion runs from 8 July to 25 July 2026 (both dates inclusive) (the “Promotion Period”).
2. The promotion is only applicable to BOC Chill Cards (Including BOC Chill World Mastercard and BOC Chill Platinum Mastercard) issued in Hong Kong bearing the BOC logo (the “Eligible Credit Card”).
3. The Eligible Credit Card customer can redeem the HYROX Experience Class (the “Event Ticket”) via the designated HK Ticketing (the “Ticketing Platform”) page during the Promotion Period.
4. Each Eligible Credit Card account will be eligible to purchase a maximum of 2 Event Tickets. The number of Event Ticket is limited by the venue and available on a first-come, first-served basis, while stocks last.
5. The price of an Event Ticket is HK\$0. Customers are required to pay the Ticketing Platform handling fee using an Eligible Credit Card.

Customers who have successfully redeemed Event Tickets are required to make retail transactions of HK\$1,000 or above for each event ticket with BOC Chill Card within 2 months after the event date. If the customer has successfully redeemed 2 Event Ticket and the event is held on 25 July, 2026, the customer is required to accumulate retail transactions of HK\$2,000 or above with BOC Chill Card on or before September 30, 2026 to meet the spending requirements. If the Customer is unable to fulfil the spending requirement, BOC Credit Card (International) Limited (the “Company”) reserve the right to deduct event ticket fee HK\$200 per ticket from the credit card account without any prior notice.
8. Event Tickets cannot be exchanged for cash/other gifts, returned or transferred, nor can they be resold.
9. Should there be any illegal or fraudulent act committed by a cardholder, the Company and/or Bank of China (Hong Kong) Limited (“BOCHK”) reserves the right to cancel the customer’s Event Tickets without prior notice. BOCHK also reserves the right to take further legal actions as deemed necessary.
10. BOCHK is not the service/product provider of this promotion event. BOCHK accepts no liability for and shall not be responsible for the quality of or any other matters relating to the products and services provided by the Organiser.
11. The event will be determined by PURE International (HK) Limited (“The Organiser”). The Organiser reserves the right to reschedule or cancel the event without any prior notice. If there is any dispute between Customers and the Organiser, the Organiser reserves the right of final decision.
12. Tickets must be valid during admission. Please keep the e-ticket properly.
13. Customers are advised to read and abide by the following terms and conditions before participating in the Activity:
 - i. All individuals entering the premises must be aged 18 years old.
 - ii. It is your responsibility to consult a physician regarding your ability to participate in the physical activities and/or use of the PURE Facilities and/or the PURE Equipment.

- iii. You shall not use any of the PURE Facilities and/or the PURE Equipment or participate in any of the physical activities available at PURE whilst suffering from any infections or contagious illness, disease or other ailment including but not limited to open cuts, abrasions, open sores or minor infections, where there is any risk that such use or participation in such condition may be detrimental to the health, safety, comfort or physical condition of other users of Pure; you will bring any such matters to the attention of the staff of PURE if in any doubt.
 - iv. The PURE Facilities and/or the PURE Equipment may result in harm to you, especially if you have not received instruction in their use by one of PURE's instructors; all equipment is different and even if you have used similar equipment it is essential you are familiar with the use of the PURE Equipment. 14. Customers acknowledges and agrees to the organizer's limitation of liability before participating in the Activity:
- i. You hereby acknowledge that you are aware that in participating in the physical activities available at PURE Fitness Sessions, and in using the PURE Facilities and/or the PURE Equipment there is the risk or possibility of injury and, without restricting the generality of the foregoing. You voluntarily accept these inherent risks. You further warrant that you have consulted a qualified medical practitioner recently and know of no reason why you should not participate in physical activities available at PURE in which you will participate. You promise that you will use the PURE Facilities and/or the PURE Equipment at all times in accordance with the instructions as to the use provided by PURE and you acknowledge that PURE will not be liable for injury or damage sustained if the PURE Facilities and/or the PURE Equipment are used before you have received proper instruction or contrary to such instruction.
 - ii. To the fullest extent permitted by applicable law, PURE, its related corporations and their respective servants, agents, employees and staff shall not be liable for any loss or damage to property or in respect of any bodily injuries, illness or death of you, your guests and/or other persons including third parties within the facilities, howsoever caused, aggravated or incurred arising out of or in any way connected with but not limited to any behavior of you or your guests, the use of the PURE Facilities and/or the PURE Equipment and other services.
 - iii. You hereby acknowledge that you understand and voluntarily accept the risks of injury involved in the use of the PURE Facilities and/or the PURE Equipment. To the fullest extent permitted by applicable laws, you hereby agree the PURE Group shall not be liable in contract, tort (including without limitation negligence), pre-contract or other representations or otherwise out of or in connection with your participation in PURE Fitness and/or usage of the PURE Facilities and/or

the PURE Equipment, for any claims, demands, damages, economic losses (including without limitation, loss of revenues, profits, contracts, business or anticipated savings), loss of good will or reputation, or special or indirect consequential losses in any case. You further agree not to hold the PURE Group liable for any willful act or omission, default, fraud or negligence of any other person or guest or third party within PURE operated facilities.

- iv. You hereby agree to defend, fully indemnify on demand and hold harmless the PURE Group from and against all liabilities, claims, expenses, damages and losses including legal fees (on an indemnity basis) which PURE Group may suffer arising from any breach of these terms and conditions by you, or in connection with any act, omission, default, negligence or conduct of you or your guest, or in connection with any other liabilities arising out of your or your guest's use of the PURE Facilities and/or the PURE Equipment or any services under this Agreement.

This obligation to indemnify PURE shall survive the termination of this Agreement.

- 15. The event will be arranged by the Organiser while the purchasing service is arranged by the Ticketing Platform. BOCHK / the Company accept no liability for any matters (including quality and supply) in relation to the Activity provided by the Organiser and/or the service provided by the Ticketing Platform. Please contact the Organiser or Ticketing Platform directly if there is any query on the ticket or the Activity.
- 16. No person other than the Eligible Customer and BOCHK will have any rights under the Contracts (Rights of Third Parties) Ordinance to enforce or enjoy the benefits of any of the provisions of these terms and conditions.
- 17. BOCHK reserves the right to change, suspend or terminate the offer or its terms and conditions at its sole discretion, and reserve the right of final decision on all matters and disputes.
- 18. Should there be any discrepancy or inconsistency between the English and the Chinese versions of these terms and conditions, the Chinese version shall prevail.
