## Terms and Conditions of "Enjoy up to HK\$600 Cash Rebate at the Apple Store Online" Program:

- 1. "Enjoy up to HK\$600 Cash Rebate at the Apple Store Online" Program (the "Program") is valid from 22 September to 21 November 2025 (both dates inclusive and based on the transaction date, the "Promotion Period").
- 2. Unless otherwise specified, the Program is applicable to transactions which are settled by BOC Visa Credit Cards and BOC Visa Co-branded Credit Cards issued in Hong Kong bearing the logo, or transactions made by Apple Pay with these physical cards (if applicable) ("Eligible Mobile Payments") but excludes BOC MasterCard, BOC Dual Currency Credit Cards, BOC Credit Cards issued in the mainland or Macau, USD Credit Cards, Private Label Cards and Intown Cards (the "Eligible Credit Card").

- 5. Customers must successfully register and make transactions using an Eligible Credit Card or Eligible Mobile Payment during the Promotion Period at the Eligible Merchants and meet the designated single net spending amount (the "Eligible Transaction") to earn the below cash rebate:
