

## **Terms and conditions of “BOC Credit Card x CINEART House Offer”:**

### **General Terms and conditions**

1. “BOC Credit Card x CINEART House Offer” includes “Buy 1 Get 1 FREE on movie ticket”, and “15% off on movie ticket / designated popcorn combo” (the Program).
2. The Program runs from now until 31 December 2025 (both days inclusive, the “Promotion Period”).
3. The Promotion is applicable to BOC Credit Cards, including BOC Co-branded Cards issued in Hong Kong bearing the BOC logo (the “Eligible Credit Card”), but excluding BOC Credit Cards issued in the mainland and Macau, Private Label Cards, BOC Purchasing Cards and USD Credit Cards.
