

**Terms and conditions of “BOC Credit Card x CINEART House Offer”:**

1. “BOC Credit Card x CINEART House Offer” includes “Buy 1 Get 1 FREE on movie ticket”, and “15% off on movie ticket / designated popcorn combo” (the Program).
2. The Program runs from now until 31 December 2026 (both days inclusive, the “Promotion Period”).
