# <u>Terms and Conditions of "Taobao Oct – Dec 2025 Promotion"</u>

- 1. "Taobao Oct Dec 2025 Promotion" (the "Promotion") consists of, "0% Handling Fee Offer", "HK\$30 Instant Discount on Instalment Plan", "Exclusive Promo Codes", and "Official 15% Off Discount" (the "Offers").
- 2. Unless specified, the Promotion runs from 12:00 HKT on 20 Oct 2025 to 23:59 HKT on 31 Dec 2025 (both dates inclusive) (the "Promotion Period").
- 3. The Promotion applies to BOC Credit Cards issued in Hong Kong bearing the logo including all Co-branded Credit Cards (the "Eligible Credit Card") but excluding BOC Credit Cards issued in Mainland China or Macau, USD Credit Cards, Private Label Cards, Intown Cards and BOC Supplementary Cards.

- Promotion Code "BOC25": Enjoy a discount of ¥25 upon actual payment of ¥288 or above

- 6. Quotas of all offers are limited and on a first-come-first-served basis in accordance with the records of the Merchant.
- 7. The offers are applicable for the order with delivery address in Hong Kong. To enjoy the Offers, each Eligible Customer is required to set the Taobao Mobile App "Payment Means Setting" to "International/ China Hong Kong Macau Taiwan Payment" and "Currency setting" to "HKD".

- 23. Should there be any discrepancy or inconsistency between the English and the Chinese version of these terms and conditions, the Chinese version shall prevail.
