

## **Terms and conditions of “Wing On Travel Offer”:**

### **General Terms and conditions**

1. “Wing On Travel Offer” includes “Up to HK\$670 Discount” and “BOC Credit Card x Wing On Travel – Wednesday Flash Sales” (the Program).
2. The Program is applicable to:
  - i. BOC Visa and BOC Mastercard Credit Cards issued in Hong Kong bearing the BOC logo, but excluding BOC Dual Currency Credit Cards, BOC Credit Cards issued in the mainland and Macau, USD Credit Cards, Private Label Cards, BOC Purchasing Cards and Intown Cards (the “Eligible Credit Card”) and/or;
