

Terms and conditions of “Wing On Travel Offer”:

General Terms and conditions

1. “Wing On Travel Offer” includes “Tours/ Cruise Time-Limited Offer” and “BOC Credit Card x Wing On Travel – Wednesday Flash Sales” (the Program).

 - i.
