

Terms and Conditions of BOC Cheers Card “The Ultimate Shanghai Race Experience” Lucky Draw:

A Registration reference number will be announced when the Registration is successful. The Promotion is only applicable to the successfully registered eligible Clients (the “Eligible Clients”). The Registration record is based on the computer record of the Company.
5. 6. Each Customer (counted by the Identification Document Number) can only win once throughout the entire Promotion Period.
7. The Customer is required to register with an Eligible Credit Card and make Eligible Spending to be Eligible. An Eligible Customer (counted by the Identification Document Number) who holds more than one Eligible Credit Card account can register only once with any one of his/her Eligible Credit Cards, and all Eligible Spending made with the Eligible Credit Card will be combined. **No Lucky Draw Entry will be granted if the Customer registers/spends with any card other than an Eligible Credit Card.**
