

Terms and Conditions of “BOC Visa Credit Card X Trip.com Up to HK\$700 Off”

1. “BOC Visa Credit Card x Trip.com Up to HK\$700 Off” (the “Promotion”) runs from 3 June – 31 August 2026 (both dates inclusive and based on the transaction date, the “Promotion Period”). The offers are subject to limited quotas and available while quotas last. The offers will end and there will not be any prior notice if the quotas are full.
2. The Program is applicable to BOC Visa Credit Cards and BOC Visa Cobranded Cards issued in Hong Kong bearing the BOC logo (the “Eligible Credit Card”), but excluding BOC Mastercard, BOC UnionPay Dual Currency Credit Cards, Private Label Cards, BOC Purchasing Cards, USD Credit Cards, Intown Cards and BOC Credit Cards issued in the mainland and Macau, BoC Pay+, and other third party mobile payment (such as but not limited to Apple Pay, Google Pay, Samsung Pay, AlipayHK, WeChat Pay, AlipayCN, WeChat Pay CN and PayPal.)
3. During the Promotion Period, the customer must log in as a member of Trip.com (the “Merchant”) successfully and make Flight, pre-paid Hotel, and Flight + Hotel Package through the Trip.com website or mobile application upon single net spending in HKD with designated amount with an Eligible Credit Card and meet the following requirements (the “Eligible Spending”) to enjoy below offers (the “Offers”):
 - i. Enjoy a HK\$200 instant discount upon single net spending of HK\$2,000 on Flight bookings (excluding taxes and fuel charges; eligible only if the flights are departing from or arriving in Hong Kong/Macau) by entering the promotion code “BOCFLIGHT” before payment settlement (“Offer 1”).
 - ii. Enjoy a HK\$250 instant discount upon single total spending of HK\$2,000 on any local/overseas pre-paid Hotel and rooms bookings by entering the promotion code “BOCHOTEL” before payment settlement (“Offer 2”).
 - iii. Enjoy a HK\$250 instant discount upon single total spending of HK\$2,000 on Flight + Hotel Package bookings by entering the promotion code “BOCBUNDLE” before payment settlement (“Offer 3”).

(a) During the Promotion Period, each customer (based on Trip.com member account) can use each promotion code twice each month and can enjoy up to 6 times throughout the Promotion Period.

- (b) The Promotion is subject to limited quotas. During the Promotion Period, Offer 1 is subject to a quota of 2,600 in total and a weekly quota of 200; Offer 2 is subject to a quota of 3,900 in total and a weekly quota of 300; Offer 3 is subject to a quota of 780 in total and a weekly quota of 60.
 - (c) There are 13 weeks in total throughout the Promotion Period (24-31 August 2026 will be the last week). The weekly quotas of Offers are issued every Wednesday at 00:00am HK time. Offer quotas are available on a first-used-first-served basis while quotas last.
 - (d) The above-mentioned Offer 1 net spending amount will be counted based on products only, excluding taxes and fuel charges, domestic flight in Mainland China, and other additional charges. The offer is only eligible if the flights are departing from or arriving in Hong Kong/Macau. The offer is not applicable to certain airlines or ticket types. Excluded airlines include: Iberia, Vueling, Flydubai, Alaska Airlines, Cebu Pacific, Firefly, Eurowings, TUI Airways, Tigerair Taiwan, Jetstar, and others. Actual eligibility is subject to system judgment at the time of booking and the checkout page.
 - (e) Offer 2 is applicable for pre-paid hotels and rooms with room rate after taxes and charges. Actual eligibility is subject to system judgment at the time of booking and the checkout page.
 - (f) The above-mentioned Offer 3 total spending amount will be counted based on products only, excluding taxes and fuel charges, domestic flight in Mainland China, and other additional charges, and it is applicable for pre-paid hotels and rooms with room rate after taxes and charges. Actual eligibility is subject to system judgment at the time of booking and the checkout page.
4. Customers must settle the payment with an Eligible Credit Card and use corresponding Promotion Code in the Fill In Page to enjoy the Offers. The Offers are available on a first-used-first-served basis while quotas last. The quotas are calculated based on the computer record of BOC Credit Card (International) Limited (the "Company") and the Merchant.
 5. The Offers will be used at the time of making the Eligible Spending, and cannot be accumulated, reissued or reserved for future use.

6. Unless otherwise specified, the Offers cannot be used in conjunction with any other discounts, Trip Coins, vouchers, promotional offers, discount items or promotional activities, unless otherwise specified. Offer is not applicable to third party promotional channels.
7. Unless otherwise specified, the Offers above cannot be exchanged for cash, gifts, services, other products, discounts or offers, and is not transferable.
8. Bank of China (Hong Kong) Limited (the "BOCHK") and/or The Company and/or the Merchant accept no liability if the customer cannot enjoy the Offers due to failure in logging in as a member of Trip.com during transactions. If customers have any enquiries relating to the Merchant services, please contact the Merchant directly.
9. Cancellation or change the schedule of flight, prepaid hotel, and flight +hotel package (if applicable) has to be arranged via the Merchant's customer service team and is subject to the terms and conditions of respective hotel / flight / flight +hotel package. Applied offers for the Eligible Spending/bookings which are then modified will be considered as invalid. The customer must cancel the original Eligible Spending/bookings and rebook in order to enjoy the Offers again. For the avoidance of any doubt, the customer will not be guaranteed to enjoy Offers again if the quota has been used up at the time they book the product again.
10. The actual selling prices of products are based on the price listed on the Merchant's website/ mobile application. The selling prices will be changed slightly from day to day based on the exchange rate fluctuation.
11. By participating in this Promotion, the customer acknowledges that he/she has read, understood, accepted and agreed to be bound by these Terms and Conditions.
12. The Company and/or the Merchant reserves the right to amend, suspend or cancel the Promotion or its terms and conditions at its sole discretion.
13. The following types of transactions shall not fall under the scope of the "Eligible Spending":

- a) Any transactions that are subject to cancellation, charge-back, return of goods and/or refund;
 - b) Any autopay, instalment, or bill payment transactions;
 - c) Transactions made via any third party or e-Wallet payment methods (including but not limited to Apple Pay, Google Pay, Samsung Pay, AlipayHK, WeChat Pay, AlipayCN, WeChat Pay CN and PayPal.);
 - d) All unposted/ cancelled/ refunded/ falsified/ unauthorised transactions;
 - e) Any other type of transaction as determined by the Company from time to time.
14. Any cancelled, refunded, falsified and unposted transactions are not counted as Eligible Spending. In case of such transactions, the Offers will be cancelled together with those transactions. Any fraud and/or abuse of the Offers by any person (as determined by BOCHK and/or the Company and/or the Merchant at their sole discretion) will result in forfeiture of the person's eligibility to the Offers. BOCHK and/or the Company and/or the Merchant reserve the right to deduct the value of any Offers redeemed inappropriately by a customer directly from any of the customer's relevant Credit Card account without prior notice, and/or take legal action in such instances to recover any outstanding amounts.
