Arrangements on dissemination of Corporate Communications

Please contact your Intermediaries for detailed procedures.**

If you wish to receive Actionable Corporate Communications via electronic dissemination, please provide your valid and functional email address to your Intermediaries. If the Intermediaries do not have your valid and functional email address, you will be unable to receive Actionable Corporate Communications in electronic form.

2. Corporate Communications

Subject to relevant laws and regulations, the Company will only send Corporate Communications in printed form to Shareholders upon their request. You are recommended to access the English and/or Chinese version(s) of the Corporate Communications in the Investor Relations section of the Company Website or browse through the HKEX Website.

If you wish to be notified when the Company publishes its Corporate Communications, you are encouraged to subscribe for the news alert service provided by HKEX Website.

3. Request for Corporate Communications in printed form

Please complete, sign and return the enclosed Request Form and send it to the Share Registrar in the aforesaid manner. **Any such request will remain valid until the instruction has been revoked or superseded or until the time when the Company publishes its next annual report in the following year (whichever is earlier).**
