Notice of Amendments to the "General Information" and "Supplemental Information On Renminbi Services"

Thank you for choosing the banking services of Bank of China (Hong Kong) Limited (the "Bank").

Please be informed that the Bank's "General Information" and "Supplemental Information On Renminbi Services" clauses have been amended and will be effective from 26 November 2018 ("Effective Date"). Please find below for amendments details. Part A below sets out a summary of the key amendments. In Part B, details of the amendments to different sections are provided for your ease of reference.

	accounts) or "CIRRUS" (applicable to BOC MasterCard Credit
	Card linked with bank accounts) (depending on the card type).
	Cash withdrawal of designated foreign currencies from your
	Multi-Currency savings account is only available at our bank's
	designated ATMs in Hong Kong."

5	Paragraph 2 under Auto-Transfer Service section of the

	"Auto-transfer Service is not applicable to cash withdrawal of
	designated foreign currencies from your Multi-Currency
	savings account at our bank's designated ATMs in Hong
	Kong."

	Renminbi Services" (Page 5) is amended as follows: "When applying
	for a BOC card, you may, in addition to registering one principal
	account, register subsidiary accounts (such as a HKD or a Renminbi
	account or a Multi-Currency savings account (including Renminbi
	and other currencies where applicable)) that you hold with us. The

	maximum number of accounts that you may register for each BOC
	Card (depending on the type of BOC Card) is subject to our revision
	from time to time."
2	Paragraph 1 of Clause 5.2 of the "Supplemental Information On
	Renminbi Services" (Page 6) is amended as follows: "You may use
	ATMs with the logo" [©] ", "JETCO", "UnionPay", "PLUS" (applicable to
	BOC VISA Credit Card linked with bank accounts) or
	"CIRRUS"(applicable to BOC MasterCard Credit Card linked with
	bank accounts) (depending on the card type). Cash withdrawal of
	designated foreign currencies from your Multi-Currency savings
	account is only available at our bank's designated ATMs in Hong
	Kong. "
3	Paragraph 5 of Clause 5.2 of the "Supplemental Information On
	Renminbi Services" (Page 6) is amended as follows: "The maximum
	daily transaction limit applicable to all existing and new issued BOC
	Card for each customer (regardless of the number of BOC Cards
	registered under the same account holder) are listed below (not
	applicable to the counter services):"
4	Remarks 1 of Paragraph 5 of Clause 5.2 of the "Supplemental
	Information On Renminbi Services" (Page 7) is amended as follows:
	"The maximum daily limit is based on HKD (for HKD or non-CNY
	foreign currency cash withdrawal) or CNY, depending on the
	currency of transaction. The exchange rates for calculation of the
	limit for cash withdrawal of designated foreign currencies (excluding
	Renminbi) at our bank's designated ATMs are subject to the
	exchange rates prescribed by BOCHK; the exchange rates for
	calculation of the limit for cash withdrawal of foreign currencies
	(excluding Renminbi) at ATMs outside Hong Kong are subject to the
	daily exchange rates prescribed by network service provider at the
	time of the transaction."

If you do not accept the amendments, we may not be able to continue to provide services to you.
