Notice of Revision of General Banking Service Charges

Please be informed that with effect from 15 July 2019 (“Effective Date”), Bank of China (Hong Kong) Limited will revise the general banking service charges listed below. Other service charges/fees items remain unchanged.

(1) Remove Bulk Cash Deposit / Transaction Fee (RMB)
