Notice of Amendments to the “General Information” and “Supplemental Information On Renminbi Services”

Thank you for choosing the banking services of Bank of China (Hong Kong) Limited (the “bank”).

Please be informed that the Bank’s “General Information” and “Supplemental Information On Renminbi Services” have been amended and will be effective from 17 November 2019 (“Effective Date”). Please find below details of the amendments. Part A below sets out a summary of the key amendments. In Part B, details of the amendments to different sections are provided for your ease of reference.

Please note that the default daily cash withdrawal limit is applicable to customers who apply for a BOC Card on or after 17 November 2019. For customers owned a BOC Card before 17 November 2019, the daily withdrawal limit will not be adjusted automatically.
