The settings will be automatically applied to all BOC Credit Cards under your name (BOC Commercial Card and Purchasing Card excluded).

If you wish to set-up the "Over-the-limit Facility" function for BOC Commercial Card, you can download the Setup of "Over-the-limit-Facility" Function Request Form from our bank's website > Home > Credit Card > Customer Service > Other Frequently Used Forms page, complete and deliver to any branch of Bank of China (Hong Kong) Limited for further processing, the settings will be automatically applied to all BOC Commercial Card(s) under your company.

You may also access our bank's website > Home > Credit Card > Customer Service page > User Agreements, Terms and Conditions page to view and download the related Terms and Conditions. Please read carefully and fully understand the Terms and Conditions for "Over-the-limit Facility" function, and agree to be bound by them (if applicable).

Unless otherwise specified, the Amendment above are applicable to all types of BOC Credit Cards (including BOC Visa Credit Card/BOC MasterCard Credit Card/BOC CUP Dual Currency Credit Card/BOC Intown Virtual Card/BOC Private Label Card/BOC Commercial Card and related supplementary cards, if applicable).

Please note that you will be deemed to have agreed to the above Amendment and will be bound by them if you continue to use or retain your credit card(s) and/or maintain the card account(s) with us on or after the Effective Date. If customers do not accept the relevant Amendment, customers of BOC Personal Card please contact us via Mobile Banking, Online Chat or call (852) 2853 8828; customers of BOC Commercial Card please complete the Set-up of "Over-the-limit-Facility" Function Request Form and deliver to any branch of Bank of China (Hong Kong) Limited to set-up "Over-the-limit Facility" function on or before 29 October 2023. Should there be any discrepancy between the English and Chinese versions of this notice, the Chinese version shall prevail.
