Newly added on "Remarks of BOC Express Cash Instalment Loan/Balance Transfer (Clause No. 12)"/"Term and Condition of "iSmart" Tax Loan (Clause No. 25)"/"Term and Condition of BOC Express Cash Revolving Credit (Clause No. 28.8)"

Big Data Analytics and Artificial Intelligence ("BDAI") technology may be used by the Bank or through its service providers in relation to customer personal or non-personal information for performing the borrower's credit and risk assessments, enhancing the Bank and customer protection, performing statistical analysis, data mining, developing and maintaining the predicative modelling, assisting in business decision-making and improving operational efficiencies. Use of BDAI by the Bank in relation to personal information is governed by the Bank's BDAI application policies, including the adoption of appropriate measures to ensure that the BDAI are developed and used ethically. Borrowers need to understand that if the personal information in the Bank is out of date or inaccurate, the analysis results of the BDAI application may be affected.
