

Open Tender Notice

A. Background:

Bank of China (Hong Kong) Limited plans to build an Innovative Technology Research Centre (GFA 48,000m²) in Hong Kong and targets to complete the project by the second half of Year 2028. We will appoint a contractor to carry out foundation and substructure works.

B. Scope of Works shall include but not limit to:

1. Piling Works
2. Site Formation Works (Soil Nail for Slope)
3. Excavation and Lateral Supporting (ELS) Works
4. Pile Cap
5. Earth Mat Installation for CLP 132kV Transformer Room
6. Other associated works

C. Eligibility criteria of the contractor with relevant supporting documents:

1. Concurrently on the Approved Suppliers of Materials and Specialist Contractors for Public Works lists, Group II (Land Piling - Rock-socketed Steel H-pile in Pre-bored Hole) of Development Bureau of HKSAR, Buildings Department for RSC (F) Register of Specialist Contractors (Sub-register of Foundation Works Category) list and Buildings Department for RSC (SF) Register of Specialist Contractors (Sub-register of Site Formation Works Category) list with the relevant supporting document;
2. Completed at least one project of rock socketed steel H pile in pre-bored hole with pile number not less than 400 in Hong Kong in the last 3 years, **or** completed at least one project of foundation works with contract value not less than HK\$200 million in Hong Kong in the last 3 years (Job location, name of employer, contract value and pile numbers should be specified and the copy of completion certificate issued by Buildings Department should be submitted);

3. Completed at least one project of site formation with soil nail for slope in Hong Kong in the last 3 years (Job location, name of employer, contract value should be specified and copy of the completion certificate issued by the Government (Such as Buildings Department) should be submitted);
4. No fatal/serious accidents for foundation works in the last 3 years (Zero accident should also be reported);
5. With ISO 9001, ISO 45001 and ISO 14001 certifications (Scanned copy is required);
6. Financial status requirements:
 - a) With positive tangible net worth for the latest year and the amount should be higher than the total estimated claimed amount of the existing lawsuit cases; and
 - b) With net profit in any one of the latest 3 years (excluding exceptional items).
(Full set of audited financial reports for the latest 3 years are required. Those submitted financial reports with inconsistent company name will not be considered. List of existing lawsuit cases with corresponding claimed amount should be provided. Declaration is required even there is no unsettled lawsuit cases).
7. Agree to cooperate with the background check process conducted by our company or our appointed agent; and
8. Copy of a valid Business Registration Certificate with consistent company name; Joint-Venture will not be considered for this tender.

*Interested companies are required to submit the Expression of Interest Form (to be downloaded at our website), together with a hard copy cover letter with company stamp, in a sealed envelope to the tender box at 23/F, BOC Wan Chai Commercial Centre, 409-415 Hennessy Road, Wan Chai, Hong Kong on or before 12:00 noon (Hong Kong time) of 1 August 2025. The Expression of Interest Form should be saved in a USB thumb drive (CD-R will not be accepted). “Expression of Interest Form for Innovative Technology Research Centre – Foundation and Substructure Works” should be indicated on the envelope. The companies which are considered to be eligible after our assessment will receive the tender documents later. **[Please note that Bank of China**

Late submission will not be accepted.
