

Open Tender Notice

A. Background:

Bank of China (Hong Kong) Limited is building an Innovative Technology Research Centre (GFA 48,000m²) in Hong Kong and targets to complete the project by the second half of Year 2028. We will appoint a contractor to supply and install generator sets.

B. Scope of works shall include but not limit to supply and installation of:

1. 2600kW High Voltage (HV) Generators for Data Center
2. HV Genset Switch Board and the distributions
3. Fuel Pump/ Underground Fuel Storage Tank and the fuel supply system
4. Other associated works

C. Eligibility criteria of the contractor with relevant supporting documents:

1. Currently on the Approved Registered Electrical Contractors List of Electrical and Mechanical Services Department. Copy of such government admission document should be submitted. (Name of interested tenderer should be consistent with the name on the approved list);
2. Interested tenderer should propose one generator brand for the tender. The generator brand must have completed at least one data center project* in Hong Kong within the past 10 years, deploying a 11kV generator set with a power output of 1800kW or above (per unit). (If the interested tenderer passes the prequalification process, the proposed generator brand cannot be changed in the tender offer, otherwise, the submitted tender will not be considered). Interested tenderer should commit to having a HV generator operation and maintenance team in Hong Kong. Details for the project reference of the proposed generator brand including the job location, name of employer, project name, project scope (including the quantities, power output and the brand of generator), copy of completion certificate etc. should be submitted;

*Data center project so quoted should comply with the definition as stated in

Section 2.1.1 of Code for Design of Data Centers 《數據中心設計規範》 under People's Republic of China National Standard (中華人民共和國國家標準)GB 50174-2017. The generator brand used in the quoted project reference must be consistent with the brand proposed, but the interested tenderer did not necessarily participate in that project before.

3. Completed at least one HV generator installation project in Hong Kong within the past 10 years. Project details such as the job location, name of employer, project name, project scope (including the brand, quantities and power output of each HV generator), copy of completion certificate etc., should be submitted;
[If the name of employer or the project name cannot be disclosed due to the signing of any confidentiality agreement, a copy of such confidentiality agreement for the project should be submitted] (Name of the interested tenderer should be consistent with the name of contractor on the completion certificate);
4. Copy of a valid authorization letter, dealer certificate, partnership agreement or the like issued by the proposed generator brand manufacturer should be provided.
(Name of the interested tenderer should be consistent with the name shown on the above documentation);
5. No fatal/serious accidents for supply and installation of generator works within the past 3 years (Zero accident should also be reported);
6. Declaration that in the past the interested tenderer together with the affiliated companies have never been convicted for violating any Competition Ordinance, entered into any out-of-court settlement agreement, nor have related cases still under review. (affiliated companies include companies within the same group, parent company, subsidiaries and other companies deemed related);
7. Declaration that no other affiliated companies are simultaneously submitting the expression of interest form for this tender (affiliated companies include companies within the same group, parent company, subsidiaries and other companies deemed related);
8. Financial status requirements:
 - a) With positive tangible net worth for the latest year and the amount should be

higher than the total estimated claimed amount of the existing lawsuit cases; and
b) With net profit in any one of the latest 3 years (excluding exceptional items);
(Full set of audited financial reports for the latest 3 years are required. Those submitted financial reports with inconsistent company name will not be considered. List of existing lawsuit cases with corresponding claimed amount should be provided. Declaration is required even there is no unsettled lawsuit cases).

9. Agree to cooperate with the background check process conducted by our company or our appointed agent; and

10. Copy of a valid Business Registration Certificate with consistent company name; Joint-Venture will not be considered for this tender.

*Interested tenderer can request for the Expression of Interest Form by sending email attached with the business registration certificate to “projectitrc@bochk.com” on or before 24 November 2025. The completed Expression of Interest Form should be saved in a USB thumb drive (CD-R will not be accepted), and be submitted **together with a cover letter hard copy stamped with company chop in a sealed envelope to the tender box designated in the aforesaid Expression of Interest Form on or before 12:00 noon (Hong Kong time) of 3 December 2025. “Expression of Interest Form for Innovative Technology Research Centre – Generator Works” should be indicated on the envelope.** The companies which are considered to be eligible after our assessment will receive the tender documents later. [Please note that Bank of China (Hong Kong) Limited does not bind itself to invite any interested party or anyone who meets the aforesaid essential qualifications to tender]

Late submission will not be accepted. If tropical cyclone signal No.8 or above is hoisted, or black rainstorm warning signal or “extreme conditions” announced by the Government is/are in force at any time between 9 a.m. to 12 noon (Hong Kong Time) on the submission closing date, the closing date will be postponed to the day after the aforesaid warning signal has/have ceased to be in force.
