BOCHK's Hong Kong Dollar interest rates remain unchanged

Bank of China (Hong Kong) Limited announces that its Hong Kong Dollar ("HKD") prime rate and savings deposit rate <u>remain unchanged</u> at 5.875% p.a. and 0.875% p.a. respectively. Under the tiered interest rate structure for HKD savings accounts, the following rates^{Note} will apply:

Daily Account Balance (HKD)	Interest Rate (p.a.)
\$5,000 or above	0.875%
Below \$5,000	0%

Bonus Scheme: Savings accounts with a daily account balance of HKD1,000,000 or above will enjoy an additional bonus rate of 0.001% p.a.
