

### **General Terms and Conditions of “Samsung Shopping Privileges” (the “Promotion”)**

1. The Promotion runs from 25 February 2026 till 30 April 2026 (both dates inclusive and based on the transaction date) (the “Promotion Period”).
2. The Promotion applies to all physical shops of Samsung Electronics H.K. Co., Ltd. (the “Merchant”) in Hong Kong (the “Shops”), Samsung App (「APP」) and Samsung online shop (the “Online Shop”).
3. Unless otherwise specified, the Promotion is applicable to the following payment methods:
  - i. BOC Dual Currency Credit Cards issued in Hong Kong bearing the BOC logo, but excluding BOC Credit Cards issued in the Mainland or Macau, USD Credit Cards, Private Label Cards and Intown Cards (the “Eligible Credit Card”); and/or
  - ii. BoC Pay+ mobile app payments, which refer to QR Code payments made with the BoC Pay+ mobile app via UnionPay network. Any transactions made with e-wallets (including but not limited to Alipay HK, WeChat Pay HK, Alipay, WeChat Pay and other designated payment means / e-Wallets as decided by the Company) (the “e-wallets”) and transactions without sales slips/records are treated as ineligible transactions.
4. Unless otherwise specified, the Promotion cannot be used in conjunction with any other promotions. Awarded Cash Rebate can neither be exchanged for cash nor refunded, and is not exchangeable for other products, transferable or saleable. All eligible transactions of the Offer will be counted based on net spending amount, while the net spending amount shall exclude any amount deducted by discount, usage of gift voucher / cash voucher / gift card amount.

To be eligible for the offer, a cardholder must make a designated single net spending with an Eligible Credit Card and/or BoC Pay+ at the shops or online shop of the Merchant, and fulfil the requirement of Eligible Transaction of the Offer during the Promotion Period, in order to be entitled to the following Cash Rebate:

23. There is a maximum cap on the Cash Rebate of the offer per each Eligible Credit Card (main card and supplementary card will be combined in the calculation). Each Eligible Credit Card can earn a maximum of HK\$2,000 Cash Rebate throughout the Promotion Period.
24. BOCHK and/or The Company will determine the eligibility of each transaction by matching the cardholder transaction records held by the Company. If the information from the cardholder differs from those of the Company records, the latter shall be final and conclusive.
