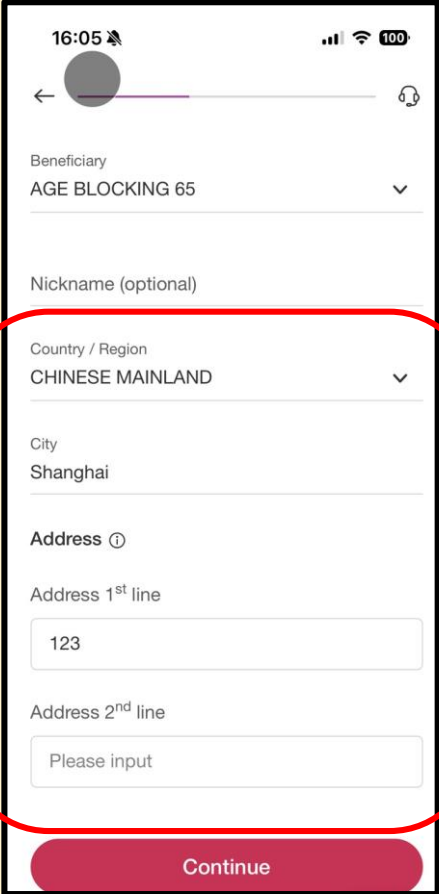
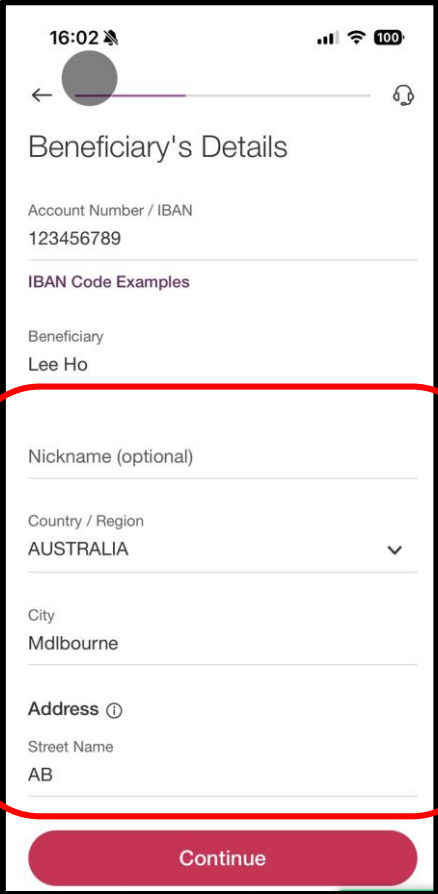


Beneficiary Address Format – Mobile banking (Register New Payee) (Path : Menu > Transfer & Payment > Remittance > To New Payee)
