## JPMorgan Funds - Emerging Markets Dividend Fund

We are writing to inform you that JPMorgan Funds - Emerging Markets Diversified Equity Fund¹ (the "Merging Sub-Fund") will be merged into JPMorgan Funds - Emerging Markets Dividend Fund (the "Receiving Sub-Fund"), a sub-fund in which you invest, on 24 April 2020 (the "Merger Date"). The Merging Sub-Fund has experienced significant outflows and the Board of Directors of JPMorgan Funds (the "Fund") believes the Merging Sub-Fund has limited prospects for growth in the future and it would be in the shareholders' interests to merge it into your sub-fund – a larger fund with stronger growth potential. This merger will not have any negative effect on the value, costs, or performance of your investment.

On the Merger Date, the assets of the Merging Sub-Fund will be transferred into the Receiving Sub-Fund. The merger will increase the assets under management of the Receiving Sub-Fund. There will be no rebalancing of the Receiving Sub-Fund and no costs associated with the merger will be borne by the Receiving Sub-Fund. When the merger transaction occurs, all the assets, liabilities and any accrued income in the Merging Sub-Fund will be transferred to the Receiving Sub-Fund, and the Merging Sub-Fund will cease to exist.

You do not need to take any action. However, if, as a consequence of the merger, you wish to redeem your shares, or switch your holding in the Receiving Sub-Fund into any other funds which are managed by JPMorgan Funds (Asia) Limited or for which it acts as Hong Kong representative<sup>2</sup> and which are authorised by the Securities and Futures Commission (the "SFC") for sale to the public in Hong Kong, you may do so free of charge during the waiver period<sup>3</sup> from 24 February 2020 until 5:00 p.m. (Hong Kong time) on 24 April 2020. All other switching and redemption conditions as disclosed in the offering document still apply. Details of such funds (including the relevant offering documents) can be found at our website am.jpmorgan.com/hk<sup>4</sup>. SFC authorisation is not a recommendation or endorsement of a fund nor does it guarantee the commercial merits of a fund or its performance. ## 摩根基金一新興市場股息收益基金

本函件旨在告知閣下,JPMorgan Funds – Emerging Markets Diversified Equity Fund¹(「合併子基金」)將於2020年4月24日(「合併日」)併入閣下所投資的摩根基金 – 新興市場股息收益基金(「接收子基金」)。合併子基金出現大量資金外流,摩根基金(「本基金」)之董事會認為合併子基金未來的增長前景有限,將其併入閣下的子基金 – 一隻規模較大且增長潛力更加強勁的子基金,符合股東的利益。是項合併不會對閣下的投資價值、成本或表現構成負面影響。

於合併日,合併子基金的資產將被轉移至接收子基金。合併將提升接收子基金的資產管理 規模。接收子基金的組合將不會重新調整,且有關合併之費用將不會由接收子基金承擔。 當合併交易發生時,合併子基金之所有資產、負債及任何累計收入將被轉移至接收子基 金,而合併子基金將不再存在。

閣下無需採取任何行動。然而,如鑑於合併,閣下希望贖回閣下之股份或轉換閣下所持接收子基金之股份至任何由摩根基金(亞洲)有限公司管理或作為香港代表人<sup>2</sup>並獲證券及期貨事務監察委員會(「證監會」)認可售予香港公眾之其他基金,閣下可於2020年2月24日至2020年4月24日下午5時正(香港時間)之豁免期內免費進行<sup>3</sup>。銷售文件內披露的所有其他轉換及贖回條件仍然適用。該等基金之詳情(包括相關銷售文件)可於am.jpmorgan.com/hk<sup>4</sup>查閱。證監會的認可並不代表其對基金的推介或認許,亦不保證基金之商業利弊或其表現。證監會的認可不表示基金適合所有投資者或認許基金適合任何個別投資者或投資者類別。
