



**Terms and conditions of Bank of China (Hong Kong) Limited (the “BOCHK”) Global Integrated Services Lucky Draw (the “Lucky Draw”)**

1. Promotion Period is from 21 January 2026 to 31 March 2026 (both dates inclusive) (the “Promotion Period”).
2. Subject to below terms and conditions, Eligible Customers (the “Eligible Customer”) will be enrolled in the Lucky Draw and have a chance to win one of the prizes (the “Lucky Draw Prize”).
  - i. Bank of China (Hong Kong) Limited (“BOCHK”) Private Wealth, Wealth Management, Enrich Banking or i-Free Banking customers (the “Integrated Banking Services Customers”) with aged 18 or above before 21 January 2026, **AND**

  - iii. The transaction date, time, exchange rate and exchange amount of Eligible Exchange Transactions as well as the Total Exchange Amount are subject to the record of BOCHK. 10. Global Remittance
  - i. Only applicable to “Global Remittance” in Mobile Banking of the Bank, which remit out successfully with remit amount HKD 1,000 (or equivalent) or above.
