1. The Hong Kong Airlines Visa Discount Promotion ("Visa Promotion ") is subject to these Terms and Conditions. By purchasing any Hong Kong Airlines air tickets via the official website of Hong Kong Airlines Limited <https://www.hkairlines.com> within the Promotion Period (defined below) with the application of the Code (defined below), you shall be deemed to have read, understood, and agreed to be bound by these Terms and Conditions.
2. This Visa Promotion is only available and applicable when a customer purchases a Hong Kong Airlines air ticket (except infant tickets) during the Promotion Period via designated locales of Hong Kong Airlines' official website

[https://www.hongkongairlines.com/en\\_CN/hx/homepage](https://www.hongkongairlines.com/en_CN/hx/homepage) (in China - Simplified Chinese and English locales) settling the payment by Visa cards in China Renminbi (CNY).

3. The Code is "VISACNHX". The Code is valid from 1 June 2024 at 00:00 to 31 August 2024 at 23:59 (both dates inclusive) (Hong Kong time) ("Promotion Period"). Air tickets can be either one-way or round-trip, and either economy class or business class. The travel period is between 1 June 2024 and 31 October 2024 (not applicable for flights with travel dates between 26 September 2024 and 4 October 2024) (Hong Kong time, both dates inclusive).
4. Customers are eligible for a 5% discount when applying the Code during the purchase. The Code is only applicable to the air ticket's net fare. The total quota of economy class and business class is limited to the first 1,000 passengers, and the payment must be made by the designated credit card at the time of purchase.

This Promo Code Campaign is applicable for flights departing from Mainland China (Beijing Capital, Beijing Daxing, Shanghai Hongqiao, Shanghai Pudong, Hangzhou, Nanjing, Haikou, Sanya, Chongqing, Chengdu Tianfu) to Hong Kong (subject to flight availability from time to time).
